

**BACKGROUND:**

**Summary**

The Assessor-County Clerk-Recorder (ACR), in accordance with Riverside County Board Policy B-4 (Rates Charged for Current Services), has determined that updates to the ACR's fees are necessary to comply with new and changing legislation as well as to fully recover operational costs. After a comprehensive fee study was conducted and reviewed by the County Auditor Controller, a proposed updated fee schedule is attached (Exhibit A) and, upon Board approval of the proposed amendments to the related County fee ordinances, will be made available to the public during normal business hours.

The following fees are new to the Fee Schedule:

- As legislated by the State of California, per the Building Homes and Jobs Act (SB-2), the County now charges a fee of \$75 per document recorded, to a maximum of three documents per parcel, at time of recordation. This fee is mandated by Section 27388.1 of the Government Code and does not require Board adoption or approval.
- For a fee of \$120, the public now has the option to conduct their wedding ceremony at the County owned and newly refurbished 14<sup>th</sup> Street Downtown Riverside Chapel. The fee includes up to forty attending guests and an opportunity to memorialize the event with photos.

The following fees have been removed from the fee schedule:


- Fictitious Business Name reports are now provided online free of charge to the public.
- Disposable cameras and video tapes are no longer desired by the public during wedding ceremonies. Therefore, they are no longer offered for purchase.

All other fees are adjusted to reflect current costs and/or legislation. The proposed fee changes will enable the Assessor-County Clerk-Recorder to recover costs to the extent allowed by pertinent government codes and board policies. The updated fees have been accounted for in the current fiscal year budget and no budget adjustment is necessary at this time. The Riverside County Auditor Controller has approved the fee changes as submitted.

(a) Increase in the Maximum Special Tax

On each July 1, following the Base Year, the Maximum Special Tax, identified in Table 1, above, shall be increased annually, commencing July 1, 2020, based on the percentage increase in the Consumer Price Index with a maximum annual increase of six percent (6%) and a minimum annual increase of two percent (2%) of the Maximum Special Tax in effect in the previous Fiscal Year.

(b) Multiple Land Use Classes

In some instances a Parcel of Developed Property may contain more than one Land Use Class. The Maximum Special Tax that may be levied on such Parcel shall be the sum of the Maximum Special Tax that can be levied for each Land Use Class located on that Parcel. For a Parcel that contains more than one Land Use Class, the Acreage of such Parcel shall be allocated to each type of property based on the amount of Acreage designated for each land use as determined by reference to the site plan approved for such Parcel. The Administrator's allocation to each Land Use Class shall be final.

**2. Approved Property**

The Maximum Special Tax for each Parcel of Approved Property shall be equal to the product of the applicable Undeveloped Property Maximum Special Tax per Acre times the Acreage of such Parcel; provided, however, for a Parcel of Approved Property that is expected to become Single Family Property as reasonably determined by the Administrator based on the Final Map for such Parcel, the Maximum Special Tax for such Parcel of Approved Property shall be calculated pursuant to Section C.1. as if such Parcel were already designated as Developed Property and classified as Single Family Property.

The Maximum Special Tax for Approved Property shall be increased annually, commencing July 1, 2020, based on the percentage increase in the Consumer Price Index with a maximum annual increase of six percent (6%) and a minimum annual

1 increase of two percent (2%) of the corresponding Maximum Special Tax in effect in the  
2 previous Fiscal Year.

3 **3. Undeveloped Property**

4 The Maximum Special Tax that may be levied and escalated for each Parcel classified as  
5 Undeveloped Property shall be \$9,892 per Acre.

6 The Maximum Special Tax for Undeveloped Property shall be increased annually,  
7 commencing July 1, 2020, based on the percentage increase in the Consumer Price  
8 Index with a maximum annual increase of six percent (6%) and a minimum annual  
increase of two percent (2%) of the corresponding Maximum Special Tax in effect in the  
previous Fiscal Year.

9 **4. Public Property and/or Property Owners Association Property**

10 The Maximum Special Tax that may be levied and escalated for each Parcel classified as  
11 Public Property and/or Property Owners Association Property shall be \$0.00 per Acre.  
12 **There shall be no levy on Public Property and/or Property Owners Association  
Property.**

13 **D. METHOD OF APPORTIONMENT OF THE SPECIAL TAX**

14 Commencing with Fiscal Year 2019-2020 and for each following Fiscal Year, the  
15 Administrator shall levy the Special Tax on all Taxable Property until the amount of  
16 Special Tax equals the Special Tax Requirement in accordance with the following steps:

17 First: The Special Tax shall be levied Proportionately on each Parcel of Developed  
18 Property at up to 100% of the applicable Maximum Special Tax as needed to satisfy the  
Special Tax Requirement;

19 Second: If additional moneys are needed to satisfy the Special Tax Requirement after  
20 the first step has been completed, the Special Tax shall be levied Proportionately on  
21 each Parcel of Approved Property at up to 100% of the Maximum Special Tax for  
Approved Property.

22 Third: If additional moneys are needed to satisfy the Special Tax Requirement after the  
23 first two steps have been completed, the Special Tax shall be levied Proportionately on  
24 each Parcel of Undeveloped Property at up to 100% of the applicable Maximum Special  
Tax for Undeveloped Property.

25 Notwithstanding the above, under no circumstances will the Special Taxes levied in any Fiscal  
26 Year against any Parcel of Residential Property for which a Certificate of Occupancy has been  
27 issued be increased by more than ten percent (10%) as a result of a delinquency in the payment  
of the Special Tax applicable to any other Parcel above the amount that would have been levied  
28 in that Fiscal Year had there never been any such delinquency or default.

1 **E. EXEMPTIONS**

2 The CFD shall not levy Special Taxes on Public Property or Property Owners Association  
3 Property within the CFD.

4 **F. MANNER OF COLLECTION**

5 The Special Tax shall be collected in the same manner and at the same time as ordinary *ad*  
6 *valorem* property taxes and shall be subject to the same penalties, the same procedure, sale  
7 and lien priority in the case of delinquency; provided, however, that the Administrator may  
8 directly bill the Special Tax, may collect Special Taxes at a different time or in a different manner  
9 if necessary to meet the financial obligations of the CFD, and provided further that the CFD may  
10 covenant to foreclose and may actually foreclose on Parcels having delinquent Special Taxes  
11 as permitted by the Act.

12 **G. APPEALS**

13 Any taxpayer may file a written appeal of the Special Tax on his/her Parcel(s) with the  
14 Administrator, provided that the appellant is current in his/her payments of Special Taxes.  
15 During pendency of an appeal, all Special Taxes must be paid on or before the payment due  
16 date established when the levy was made. The appeal must specify the reasons why the  
17 appellant claims the Special Tax is in error. The Administrator shall review the appeal, meet  
18 with the appellant if the Administrator deems necessary, and advise the appellant of its  
19 determination. If the Administrator agrees with the appellant, the Administrator shall grant a  
20 credit to eliminate or reduce future Special Taxes on the appellant's Parcel(s). No refunds of  
21 previously paid Special Taxes shall be made.

22 The Administrator shall interpret this Rate and Method of Apportionment and make  
23 determinations relative to the annual levy and administration of the Special Tax and any  
24 taxpayer who appeals, as herein specified.

25 **H. TERM OF THE SPECIAL TAX**

26 The Special Tax shall be levied annually in perpetuity unless terminated earlier by the County.

(AS AMENDED THROUGH 729.8)  
AN ORDINANCE OF THE COUNTY OF RIVERSIDE  
ESTABLISHING FEES, CHARGES AND RATES FOR  
ASSESSOR, COUNTY CLERK AND RECORDER SERVICES**

The Board of Supervisors of the County of Riverside, State of California, ordains as follows:

**Section 1. PURPOSE AND SCOPE.**

- A. **PURPOSE.** The purpose of this section is to establish fees in reasonable amounts to cover the costs of rendering certain enumerated services and supplies furnished by the Assessor-County Clerk-Recorder's Office.
- B. **AUTHORITY.** The authority for the fees established herein is found in Government Code Sections 6157, 6253, 8201.1, 8213, 12194, 26831, 26836, 26840, 26840.1, 26840.2, 26840.3, 26840.7, 26840.8, 26849.1, 26850, 26851, 26852, 26855, 26855.1, 26855.2, 26855.3, 26861, 27293, 27361, 27361.9, 27364, 27366, 27372, 27387, 27397, 27585, 54985, 54986, 65092; Business and Professional Code 6404, 6405, 17926, 17929, 22352, 22353, 22453, 22455, 22457, 27366; Civil Code 3097; Corporations Code 14502; Family Code 360, 401, 506, 536, 1852; Fish and Game 711.4; Health & Safety 100430, 103525.5, 103625; Penal Code 14251; Welfare and Institutions Code 18966.

**Section 2. SEVERABILITY.** Should any fee herein established be held to be invalid or otherwise unenforceable, such determination shall not affect the validity of all remaining fee provisions.

**Section 3. LISTING NOT COMPREHENSIVE.** This Ordinance is not intended to contain all fees that are or may be charged by the Assessor-County Clerk-Recorder for services and supplies and to the extent that other fees are customarily charged or are established elsewhere and are not listed below, all such fees, charges, and rates shall remain in full force and effect.

**Section 4. FEE SCHEDULE.** The Assessor-County Clerk-Recorder shall hereafter collect the following fees for the services or product rendered:

**AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE 735  
ESTABLISHING FEES FOR THE SEPARATE ASSESSMENT  
OF TIMESHARE PROJECTS**

The Board of Supervisors of the County of Riverside, State of California, ordains as follows:

**Section 1. Purpose and Authority.** This ordinance adopts and establishes fees for the separate assessment of timeshare projects as provided in Revenue and Taxation Code sections 2188.8 and 2188.9.

**Section 2. Application.** The fees set out herein are charges for the initial and the ongoing costs of the separate assessment and billing and mailings with respect to timeshare projects made in accordance with Revenue and Taxation Code sections 2188.8 and 2188.9. This ordinance is intended to be applicable to assessments on the 1993-94 assessment roll and subsequent assessment rolls.

**Section 3. Fees.** The following fees shall be charged for each timeshare project separate assessment made by the County Assessor under Revenue and Taxation Code sections 2188.8 and 2188.9:

**Section 4. Levy and Collection.** For the 1993-94 assessment roll, the timeshare separate assessments that are subject to the provisions of this ordinance, and which are to be added to the specified assessments by the County Auditor-Controller, are as set out on the report of the County Assessor accompanying the notice of public hearing given in consideration of the adoption of this ordinance. For assessment rolls subsequent to 1993-94, the County Assessor shall submit a report identifying each timeshare project in which separate assessments that are subject to the fees established herein have been made to the Board of Supervisors at a regularly scheduled meeting of the Board on or before August 15 of each year. On receipt and filing of the report, the County Auditor-Controller shall levy the indicated fees on the assessment numbers as reported by the Assessor. For 1993-94 and years thereafter, the fees shall be billed and collected along with the regular taxes and assessments related to each timeshare project separate assessment and shall be subject to the same delinquency penalties and interest otherwise applicable to the regular taxes and assessments. When collected, the fees and any applicable penalties and interest shall be deposited into the County general fund.

**Section 5. Severability.** If any clause, provision, sentence, or paragraph of this ordinance, or the application thereof, is deemed to be invalid as to any person, entity, establishment, or circumstance, such invalidity shall not affect the other provisions of this ordinance which shall still be in effect, and, to this end, it is hereby declared that the provisions of this ordinance are severable.



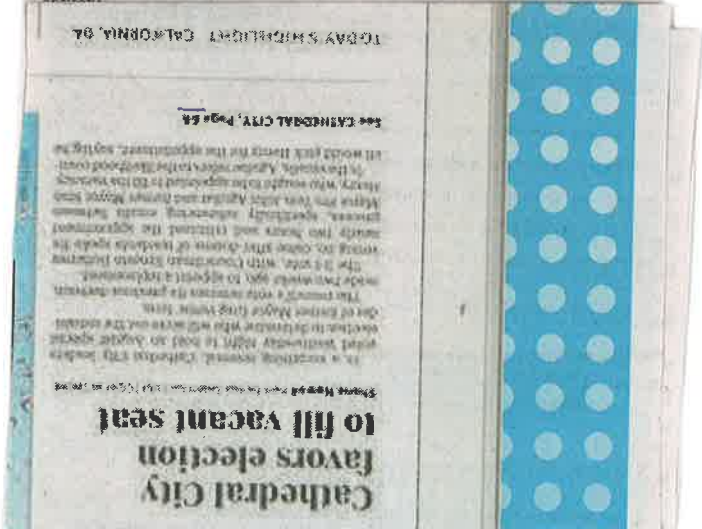
