

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

- 1. Hospice of the Valleys - \$1,500** funds will be used to offset the cost of hospice support for underinsured and uninsured patients of the 1<sup>st</sup> District. Specifically, the funds will be used to help cover the costs of unreimbursed supplies and equipment, community education and bereavement costs not otherwise covered by insurance.
- 2. Smiles for Seniors Foundation- \$1,000** to support their efforts of providing emergency assistance for food, housing and utility payments as well as home and auto repair, and help pay for life saving prescriptions, and medical equipment for senior citizens in the 1st District.
- 3. Grove Community Church - \$5,270** Funding will be used to purchase and install a video surveillance system to support The Grove's efforts to improve security and decrease vandalism at the Good Hope Moses-Schaffer Community Center and Park.
