BACKGROUND:

Summary

On November 6, 2018, Item 3.15, the Board of Supervisors (Board) approved the plans and specifications for the Sheriff's SITE-B Counseling Rooms and Restrooms Project and authorized the Clerk of the Board to advertise for bids using the approved Pre-Qualified List of Justice and/or Detention Facilities Level I contractors.

On January 31, 2019, a bid opening was conducted and the Economic Development Agency (EDA) received two bids which exceeded the approved construction budget of \$150,000. In an effort to maximize the competitive pricing received, it is herein recommended to reject all bids and rebid to all pre-qualified general contractors. An alternative procurement effort through job order contracting was also pursued however it did not yield an acceptable quote.

On June 4, 2019, Item 3.7, the Board approved the 2019 Pre-Qualified List of General Contractors for construction or renovation of County facilities. EDA recommends the Board authorize the Clerk of the Board to re-advertise the Notice Inviting Bids for the Project and solicit bids from the 2019 Pre-Qualified General County contractor lists.

Impact on Residents and Businesses

The Project will allow the staff to continue conducting class and not have to interrupt the class session to escort inmates outside the classroom. The additional counseling rooms will help to facilitate one-on-one counseling sessions between counselors and inmates as well.

Additional Fiscal Information

The project budget in the amount of \$256,850 was previously approved by the Board on May 23, 2017 (Item 3.27) and is 100% funded by Inmate Welfare Fund 65755. This Board action will have no financial impact to the Project.
