BACKGROUND:

Summary

The County of Riverside provides employees with savings plan options for retirement which includes a 457(b) Deferred Compensation Plan, Money Purchase Plan, and a Supplemental Contribution Plan. Each plan allows employees to save on a tax deferred basis towards retirement. The County offers employees a choice of two vendors, AIG Retirement (formerly VALIC), and Nationwide Retirement Solutions. AIG has provided deferred compensation services to the County since 1999 with approximately \$263 million in employer plan assets. Nationwide Retirement Solutions has provided deferred compensation services to the County since 1987 with approximately \$679 million in employer plan assets.

County of Riverside has established a Custodial account for which AIG Federal Savings Bank serves as Custodian and is required to authorize individuals holding certain positions with the County to act on behalf of the Plan. There are two categories of responsibility 1) Act on behalf of the Plan given the fullest authority. The incumbents in these identified positions will be empowered during their incumbency period to execute any documents that AIG Federal Savings Bank and the County require to the opening or maintaining of an account for the Plan;
