**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

- 1. District Attorney Crime Prevention Foundation \$2,500 the funding will be utilized for the DA's Crime Prevention Unit which works to significantly and positively impact the lives of at-risk youth and to enhance public safety, and to prevent youth from becoming involved in the criminal justice system.
- 2. Student of the Month Program \$3,000 the funding will be used to recognize and financially support the Student of the Year Scholarship program.
- 3. California Family Life Center \$2,500 the funding will be utilized for the Kin Care "Our Family Our Future Program." The mentioned program is designed to help relative caregivers who are raising relative children with tutoring services, family therapy and guardianship assistance.
- 4. Trauma Intervention Programs SWRC \$1,500 the funding will be used for a fundraiser that supports and offers emotional first aid and practical support to residents in crisis during the first hours following a traumatic event.
- 5. Exceed \$2,500 the funding will be utilized for a technology upgrade at the Exceed Program. All of Exceeds programs benefit adults with disabilities to reach their maximum potential. The technology upgrade will assist Exceeds case managers to better serve the clients at Exceed.
- 6. Hemet Community Pantry \$5,000 the funding will be utilized for the "Seniors First" Program which supplies food, rental assistance and utility assistance for the residents of Hemet.
