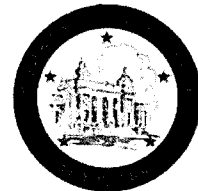





BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The Debbie Chisholm Memorial Foundation - \$2,500 the funding will be used for a fundraiser to support "Spirit of the Holidays" for children who are battling the disease of cancer.
2. Smiles for Seniors Foundation - \$1,500 the funding will be utilized for an emergency assistance program specifically for senior citizens who may need assistance paying for basic necessities to survive such as food, medications and medical equipment.
3. Hemet Sunset Rotary - \$2,500 the funds will be used for the Festival of Frights Fundraiser to raise funds for improvements to the local parks in the Hemet area.
4. Reaching New Heights Foundation - \$3,000 the funding will be utilized for the Riverside County Veterans Stand Down event that serves Riverside County. Specifically, for housing, food, bus/gas cards for veterans.
5. Villa Chardonnay - \$3,500 the funding will be used to purchase automatic water feeders for animals in remote areas of the animal sanctuary.
6. Center Against Sexual Assault of Southwest Riverside - \$7,500 the funding will be utilized to purchase advanced training for the Child Abuse Treatment Program at the Center for Sexual Assault of Southwest Riverside. The training consists of counseling victims who have experienced trauma and especially victims of sexual assault.
7. United Way of the Inland Valleys - \$2,500 the funding will be used to support the GEMS program which assists 7th grade girls in improving content knowledge in mathematics and encourages them to develop a passion for coursework in science, technology, engineering and mathematics, (STEM).
