Upon completion of the bid process, authorize the Assistant County Executive Officer/ECD to submit the contract for award of the bid to the lowest responsive and responsible bidder to the Chairman of the Board (Chairman), and authorize the Chairman to execute the contract on behalf of the Board; provided that, if any of the following occur, the award will be submitted to the Board for action: there is a bid protest, the lowest bid exceeds the estimated construction budget, the low bidder is disqualified, two or more bids are the same and are the lowest, or a bidder requests relief from its bid due to an error; and
- 3. Authorize the Assistant County Executive Officer/ECD to administer the contract for the awarded low bidder in accordance with applicable Board policies.

BACKGROUND:

Summary

On June 5, 2018, Item 3.7, the Board of Supervisors (Board) approved the JV Boxing Club Parking Lot Project in-principle and project budget in the amount of \$397,815.

The Economic Development Agency (EDA) procured services from Cozad & Fox, Inc. from the pre-qualified list of architectural and engineering design firms for the Project. The plans and specifications have been completed and reviewed by permitting authorities. EDA recommends the Board approve the plans and specifications and authorize the Clerk of the Board to advertise the Notice Inviting Bids for the Project. Upon completion of the bid process, authorize the Chairman to execute the agreement on behalf of the Board provided the lowest bid falls within the allotted project budget amount for construction and no disputes arise.

Impact on Residents and Businesses

The Project will provide improved and convenient parking access to patrons, visitors, and staff at the JV Boxing Club.

Additional Fiscal Information

The project budget in the amount of \$397,815 was previously approved by the Board on June 5, 2018 (Item 3.7) and is 100% funded by the Community Development Block Grant Fund. This Board action will have no financial impact to the Project.
