



**BACKGROUND:**

**Summary**

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the August 27, 2019 Special District Mail Ballot Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On July 23, 2019, the Board of Supervisors approved the conduct of election services for the Special District Mail Ballot Election. The jurisdiction will reimburse the County for the full cost of conducting their election.

The election was held on August 27, 2019 with 14.29% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the Special District Mail Ballot Election held August 27, 2019.

**Impact on Residents and Businesses**

Landowners in the Temescal Valley Water District had the opportunity to elect the Director for their respective district.

**Additional Fiscal Information**

As approved by the Board of Supervisors on July 23, 2019, the County will receive reimbursements from the jurisdiction for the full costs of conducting their election.
