



BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the August 27, 2019 City of Cathedral City Special Vacancy Mail Ballot Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On July 23, 2019, the Board of Supervisors approved the conduct of election services for the City of Cathedral City Special Vacancy Mail Ballot Election. Election costs fully reimbursable from the City of Cathedral City are approximately \$11,800.

The election was successfully held on August 27, 2019 with 31.64% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast for the City of Cathedral City Special Vacancy Mail Ballot Election.

Impact on Residents and Businesses

Registered voters in the City of Cathedral City had the opportunity to vote for a City Council member in City Council District 1.

Additional Fiscal Information

As approved by the Board of Supervisors on July 23, 2019, the County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election.
