

BACKGROUND:

Summary

The Application for the County-Wide Arts Services, which is to be submitted to the California Arts Council, requires a local government resolution designating the Riverside Arts Council as the organization to execute the 2019-2022 State-Local Partnership Program Grant Contract with the California Arts Council.

This was an ongoing requirement which the Board of Supervisors has supported with its approval annually for 20 years, until the California Arts Council suspended State-Local Partnership funding in 2002.
