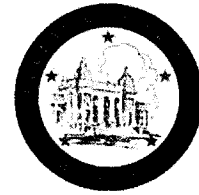

**BACKGROUND:**

1. The donation to the Kiwanis Club of Uptown Riverside will be used to sponsor their "Riverside's Got Talent" event which raises about \$40,000 which will be used to adopt 200 families for the holidays. They also support Operation School Bell which provides school clothes and supplies to underserved elementary school children.
2. The donation to the Riverside University Health System Foundation will be used to sponsor their annual event "Festival of Trees." Funds raised at this event will be used to provide equipment at the medical center's units that serve children.
3. The donation to the Riverside County Foundation on Aging will be used to provide grocery gift cards to needy seniors throughout the Second District during the upcoming holidays.
4. The donation to the Arthritis Foundation Orange County Inland Empire will be used to sponsor their "Jingle Bell Run" which raises funds for education and research as well as offering resources to help people deal with the difficulties of living with arthritis.
