#### **Summary**

Pursuant to the Riverside Community Housing Corp. (RCHC) Bylaws, the power to manage RCHC's activities and affairs is exercised by the Board of Directors. The Bylaws permit the Board to delegate the management of the corporation's activities to any person or persons. The Delegation of Authority Policy was approved by the Board of Directors on September 9, 2014, with a 5 year term. The current Delegation of Authority Policy has since expired as of August 5, 2019. Staff recommends ratifying and approving the updated Delegated Authority Policy, attached hereto. Continuing the Delegation of Authority Policy will continue to allow RCHC to streamline its processes and decrease costs associated with processing of documents.

# A RESOLUTION OF THE BOARD OF DIRECTORS OF THE RIVERSIDE COMMUNITY HOUSING CORP. ESTABLISHING A DELEGATED AUTHORITY POLICY

WHEREAS, pursuant to Article 7 of the 2014 Amended and Restated Bylaw ("Bylaws") of the Riverside Community Housing Corp. (RCHC), the power to manage RCHC's activities and affairs is exercised by and under the direction of the Board of Directors of the Riverside Community Housing Corp.; and,

WHEREAS, pursuant to Articles 7 and 9 of the Bylaws, the Board of Directors of RCHC may delegate certain authorities to manage the day to day activities and affairs of RCHC to any persons, including corporate officers of RCHC; and,

WHEREAS, on September 9, 2014, the Board of Directors of RCHC established a Delegated Authority Policy which was effective for 5 years and expired on August 5, 2019; and,

WHEREAS, the Board of Directors of RCHC now desires to renew the Delegated Authority Policy of RCHC;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Directors of the Riverside Community Housing Corp. ("Board"), in regular session assembled on September 24, 2019, that the Board hereby establishes the Delegated Authority Policy to certain corporate officers of RCHC, subject to the Bylaws and the California Nonprofit Corporation Law (California Corporations Code Sections 5000 et seq.), as further described in the Riverside Community Housing Corp. Delegated Authority Policy, attached hereto as Exhibit "A" and by this reference incorporated herein.

BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that upon adoption of this Resolution by the Board, the Delegated Authority Policy shall be effective on August 6, 2019.

# EXHIBIT A RIVERSIDE COMMUNITY HOUSING CORP. DELEGATED AUTHORITY POLICY

- I. Purpose. The purpose of this Delegated Authority Policy ("Policy") is to delegate authority to designated Riverside Community Housing Corp. ("RCHC) Officers to execute contracts and other legal documents as specifically set forth herein.
- II. Delegation of Authority. The Board of Directors of RCHC hereby authorizes and empowers the following RCHC Officers as designees with delegated authority to execute and enter into contracts, and other legal documents, binding the corporation, subject to the specific limitations set forth below:

OFFICERS WITH DELEGATED AUTHORITY
Chief Executive Officer
Chief Operating Officer
Secretary
Chief Financial Officer

III. Expenditure Threshold Limitations of Delegated Authority. Delegated authority is limited on contracts and other legal documents which require associated expenditures by RCHC. The expenditure threshold is the dollar amount which would be required to be expended by RCHC as a result of entering into that contract. The designated Officers are subject to expenditure thresholds as follows:

OFFICER	EXEPENDITURE THRESHOLD		
Chief Executive Officer	\$75,000		
Chief Operating Officer	\$75,000		
Secretary	\$25,000		
Chief Financial Officer	\$7,500		

- IV. Transfer of Delegated Authority. The delegation of authorities established in this Policy shall transfer to any equivalent successor officer positions to the positions named herein.
- V. Effective Date. This Delegated Authority Policy shall be effective retroactively as of August 6, 2019.
- VI. Amendments. Any modifications or amendments to this Policy shall be made only by resolution and upon written approval of the RCHC Board of Directors
