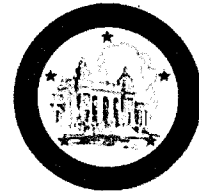



2. Authorize the release of retained funds to the contractor, Aptim Environmental & Infrastructure, Inc., in the amount of \$7,985.62 for the above referenced phases of work in accordance with the contract terms and applicable law; and
3. Direct the Clerk of the Board to record the executed Notice of Completions for each location and, upon recordation, return the conformed copies to the Department.



BACKGROUND:

Summary

On March 20, 2018 (Agenda Item 12.3), the Board awarded Aptim Environmental & Infrastructure, Inc., a three-year contract for Construction of Landfill Gas Collection System Components at the Badlands, Highgrove, and Lamb Canyon Sanitary Landfills and as needed Perimeter Probe Installation at all Department Landfills.

Construction of the Landfill Gas Collection System Expansion for Fiscal Year 2018/2019 Phase 2 at the Badlands Sanitary Landfill was satisfactorily completed by Aptim Environmental & Infrastructure, Inc. at a cost of \$92,100.00 (Retained Funds of \$4,605.00) and staff therefore recommends approval of the Notice of Completion. The Notice of Completion here is for completed work associated with a Notice to Proceed dated May 23, 2019.

Construction of the Landfill Gas Collection System Expansion for Fiscal Year 2018/2019 Phase 2 at the Lamb Canyon Sanitary Landfill was satisfactorily completed by Aptim Environmental & Infrastructure, Inc. at a cost of \$55,212.50 (Retained Funds of \$2,760.62) and staff recommends approval of the Notice of Completion. The Notice of Completion here is for completed work associated with a Notice to Proceed dated June 5, 2019.

Perimeter Probe Installation for Fiscal Year 2019/2020 at the Menifee Sanitary Landfill was satisfactorily completed by Aptim Environmental & Infrastructure, Inc. at a cost of \$12,400.00 (Retained Funds of \$620.00) and staff therefore recommends approval of the Notice of Completion. The Notice of Completion here is for completed work associated with a Notice to Proceed dated July 23, 2019.

Impact on Residents and Businesses

This contract ensures the Department's ability to efficiently collect the landfill gas generated at the Badlands, Highgrove, and Lamb Canyon Landfills and to monitor the landfill gas migration at all Department Landfills to maintain compliance with air quality regulations.

2018/2019 Phase 2 at the Badlands Sanitary Landfill, and Perimeter Probe Installation for Fiscal Year 2019/2020 at the Menifee Landfill. No funds are being requested.

Under this contract to date, a total of three (3) construction phases have been completed at the Badlands Landfill, three (3) construction phases at the Lamb Canyon Landfill, one (1) construction phase at the Highgrove Landfill, one (1) construction phase at the Corona Landfill, and one (1) construction phase at the Menifee Landfill. A cost summary by construction phase and location is summarized below. The total amount of the contract expended to date is \$507,331.50. The remaining contract amount is \$1,106,963.50. Department staff recommends authorization by the Board of Supervisors to release the retained funds to the contractor, Aptim Environmental & Infrastructure, Inc., in the amount of \$7,985.62 for the above referenced phase of work in accordance with the contract terms and applicable law.
