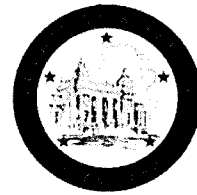



BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Murrieta/ Wildomar Chamber of Commerce - \$2,000 the funding will be utilized for two programs: Murrieta State of the City and the Murrieta / Wildomar Annual Awards events. The first, Murrieta State of the City event - \$1,000 will be used to provide a venue to communicate directly to the citizens of Murrieta as to current and future initiatives within the city. The second, Murrieta / Wildomar Annual Awards event - \$1,000 will be used to deliver logistical support for the event that honors and recognizes outstanding businesses in the local community.
2. American Association of University Women – Temecula Valley - \$2,000 the funding will be used toward scholarships for seventh and eighth grade girls to attend STEM camp at the University of San Diego.
3. Riverside County Sheriff Department - \$1,000 the funding will go towards the annual awards ceremony to recognize members of sworn and non-sworn staff and volunteers. The department also recognizes members of the community for service and assistance for their fellow citizens.
4. Soroptimist International, San Jacinto / Hemet - \$1,000 will fund the Girls Power Conference for girls in the 6th and 7th grade. The program offers educational tools to combat bullying and domestic violence issues.
5. Safe Family Justice Centers - \$5,000 the funding will be used to expand youth programs for kids exposed to adversity and violence, and help youth gain strength and skills to grow to become individuals that are confident, have a stronger sense of self-worth, empowerment, and practice good interpersonal boundaries.
6. Assistance League of Temecula Valley - \$3,000 the funding will go towards Operation School Bell which provides new, school-appropriate clothing for low income children (K-12) who reside in Temecula, Murrieta and the unincorporated areas of Southwest.
