BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Friends of Valley-Wide Foundation \$9,000 the funding will go toward sports scholarships for low-income children in the Hemet, San Jacinto, Winchester areas and park improvements.
- 2. 100 Mile Club \$2,500 the funding will be used to help prevent and reduce obesity in children by creating fitness opportunities available in schools, and empowering kids to achieve a healthy lifestyle they can maintain.
- 3. Temecula Valley Symphony \$2,500 the funding will be utilized to support the "Young Artist Competition" in Temecula, which provides an educational experience for the young performers.
- 4. All From the Heart \$2,500 the funding will go toward the "Wheels for Warriors Program" which refurbishes medical equipment and wheel chairs to an almost new condition then provides to veterans in need of the equipment.
- 5. Assistance League of Hemacinto \$3,000 the funding will be used to support "Operation School Bell" which provides clothing to elementary age children in the Hemet, San Jacinto, and the mountain communities.
- 6. Hemet / San Jacinto Chamber of Commerce \$3,000 the funding will be utilized for two programs: Hemet State of the City and the Hemet Annual Awards events. The first, Hemet State of the City event \$1,500 will be used to provide a venue to communicate directly to the citizens of Hemet as to current and future initiatives within the city. The second, Hemet / San Jacinto Annual Awards event \$1,500 will be used to deliver logistical support for the event that honors and recognizes outstanding businesses in the local community.
