[\$100,000, 100% State]

RECOMMENDED MOTION: That the Board of Supervisors:


1. Adopt Resolution No. 2019-244 which contains authorization and approval required by the California Health Facilities Financing Authority (CHFFA) for the County of Riverside (County) to proceed with submitting a formal application for funding under the Community Services Infrastructure Grant Program Application;
2. Authorize the Economic Development Agency (EDA) to incur any relevant and necessary costs not-to-exceed \$100,000 required to submit a competitive application to CHFFA including but not limited to any preliminary design and building assessment costs with reimbursement from RUHS – Behavioral Health;
3. Authorize the Behavioral Health Director, or his designee, to execute any subsequent documents that are required to submit a complete and competitive application to CHFFA; and
4. Delegate project management authority for the project to the Assistant County Executive Officer/ECD in accordance with applicable Board policies, including the authority to utilize consultants on the approved pre-qualified list for services in connection with the project, and are within the approved project budget.

BACKGROUND:

Summary

On June 27, 2016, Senate Bill 843, Section 52 became a law establishing a competitive grant program to disburse funds for the purpose of creating and expanding community alternatives to incarceration.

In September 2018, the California Health Facilities Financing Authority (CHFFA) released the Community Services Infrastructure (CSI) Grant Program Application to solicit proposals for a conditional award of \$65,813,000 for allocation amongst eligible California counties to fund capital projects with programming that offers mental health, or substance abuse treatment. Based on population size, Riverside County was eligible to apply for a maximum amount of \$4,000,000 to support the acquisition and/or renovation(s) of facilities to provide integrated mental health and substance abuse treatment to the target population.

In April 2019, Riverside County applied for and was subsequently awarded \$4,000,000 by CHFFA for the CSI Grant Program. The funding, awarded on July 25, 2019, will be utilized towards establishing the Arlington Recovery Community (ARC) Program, a 54-bed facility to provide a full array of services for people afflicted with chronic mental illness and addiction in danger of incarceration in Riverside County. Integrated care will provide residential and intensive outpatient treatment, case management, support, and wraparound services based on the principles of mental health and substance abuse recovery. Additionally, physical health care will be offered to ensure that the consumer is receiving the appropriate level of care. To implement the ARC Program, RUHS-BH is intending to renovate the former Van Horn Regional Treatment Facility, located at 10001 County Farm Road in Riverside; preliminary project cost is \$21,000,000.

In October 2019, CHFFA announced the Second Funding Round for the CSI Grant Program. Therefore, RUHS-BH is seeking approval and authorization to apply for additional funding. The new application aims to augment the Continuum of Care designed for the ARC Program by creating a Sobering Center; whereby individuals in acute intoxication of alcohol and other drugs, which do not meet the necessity of medical intervention, can be stabilized over a brief period of time instead of incarceration or admittance to Emergency Services.

Specific details regarding the project description, footprint and site plan are unknown and will be further defined during the design process. Any attempt at assessing the potential impacts at this time would be wholly speculative and, therefore, the proposed action is not considered a project under the California Environmental Quality Act (CEQA). The project will undergo environmental review once a conceptual design is completed that will allow for a meaningful evaluation of potential impacts. The compliance document under CEQA will be presented to the Board for approval in combination with the design submittal. Preliminary project cost is estimated at \$7,000,000.

Impact on Residents and Businesses

These services are a component of Behavioral Health's system of care aimed at improving the health and safety of consumers and the community.
