SUMMARY OF ORDINANCE NO. 784.11
AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 784
CREATING THE RIVERSIDE COUNTY CHILDREN AND FAMILIES FIRST
COMMISSION PURSUANT TO HEALTH AND SAFETY CODE SECTION 130140

This summary is presented pursuant to California Government Code Section 25124(b): a certified copy of the full text of Ordinance No. 784.11 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside, located at 4080 Lemon Street, 1st Floor, Riverside, California.

Ordinance No. 784.11 amends Ordinance No. 784 in its entirety to revise the Riverside County Children and Families First Commission membership requirements. The revised membership requirements are intended to ensure that the members have expertise in providing services that support early childhood development for children and families from prenatal to age five (5).

The purpose of the Riverside County Children and Families First Commission is to provide a comprehensive, collaborative, and integrated system to promote, and support early childhood development from prenatal to five (5) years of age. Ordinance No. 784.11 sets forth the Riverside County Children and Families First Commission's membership to ensure the areas of health and human services, education, and pediatric care are represented. Ordinance No. 784.11 would take effect 30 days after its adoption.

AN ORDINANCE OF THE COUNTY OF RIVERSIDE

AMENDING ORDINANCE NO. 348 RELATING TO ZONING
