

**BACKGROUND:**

**Summary**

The Grants to Support Families in the Justice System Program (referred to as the Justice for Families Program) was authorized in the Violence Against Women Act (VAWA) of 2013 to improve the response of the civil and criminal justice systems to families with a history of domestic violence, dating violence, sexual assault, and stalking, or in cases involving allegations of child sexual abuse. The program supports the following activities for improving the capacity of courts and communities to respond to families affected by the targeted crimes: court-based and court-related programs; supervised visitation and safe exchange by and between parents; training for people who work with families in the court system; civil legal services; and the provision of resources in juvenile court matters.

Approximately \$11,000,000 is available for funding, with each project being awarded up to \$550,000. The grant award performance period is 36 months, beginning October 1, 2020 and ending September 30, 2023.

Award documents will be submitted to the Board for approval once the grant funds are awarded. Upon final award, the financial data portion of this form will be completed.


**Impact on Residents and Businesses**
