

BACKGROUND:

Summary

The Economic Development Agency (EDA) is proposing the adoption of hourly rates for FY 2020/21 to recover costs associated with the provision of project management services to its customers as specified in Attachment A. In accordance with Board Policy B-4 and B-28, EDA brings cost recovery rates to the Board of Supervisors for approval and adoption on an annual basis.

The EDA Project Management Office (PMO) operates as a General Support Service (GSS) department and must recover its operating costs through charges to customers. PMO rates were derived by combining direct and indirect costs to run and operate the division divided by the annual estimated billable hours.

The PMO provides several types of services that include project management, construction inspection, environmental, and project support services. These services are charged to projects based on the number of hours worked multiplied by the board approved hourly rate. Customers are provided with project budget estimates for approval and are billed in the arrears on a monthly basis.

The proposed FY 2020/21 PMO rates have increased from the FY 2019/20 approved rate by an overall average of 2.3% due to the funding of existing positions and increases to benefit costs. The Division has incorporated efficiencies in project delivery services resulting in lower rate impacts. The proposed billable hourly rates will ensure full cost recovery of project management and plan check and inspection services.

EDA has complied with Board policies B-4 and B-28. The Executive Office and the Auditor-Controller's Office have reviewed the proposed rates and methodology.

Impact on Residents and Businesses

There is no foreseeable impact on residents and businesses.

Additional Fiscal Information

The proposed rate increase will assist in full cost recovery for the PMO.
