



BACKGROUND:

Summary

The County of Riverside Transportation Department proposes to resurface an approximate 0.5 mile segment of Datil Road from Thelma Avenue to San Miguelito Drive and an approximate 0.25 mile segment of Sierra Del Sol from Ramon Road to La Canada Way, in the Community of Thousand Palms, in the Coachella Valley area of Riverside County.

Two projects are combined to bid as one project in order to gain cost efficiencies by eliminating multiple bidding and administrative procedures and to seek more favorable proposed costs associated with larger bid quantities.

Roadway resurfacing is needed due to the deteriorated pavement conditions. The proposed resurfacing of Datil Road and Sierra Del Sol consists of grinding the existing asphalt concrete pavement in place and placing new hot mix asphalt. Shoulder backing material will be placed to protect the outside edge of pavement to prevent edge cracking and pavement edge deterioration.

Additional improvements include reconstruction of driveways, curb ramp, asphalt concrete dike, installation of traffic striping, thermoplastic pavement markings, installation of traffic signs and other associated work.

On April 28, 2017, Senate Bill 1 (SB-1) was passed to improve the state's aging transportation infrastructure, particularly roads and bridges. Because of this, the County is now able to improve the condition of roads in need of resurfacing or reconstruction and has included them in the County Transportation Improvement Program (TIP). Datil Road and Sierra Del Sol resurfacing projects are two of Riverside County's priority projects approved for use of the new Gas Tax/SB-1 funds. Without SB-1 this needed road repair project would have been shelved until funding became available.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental Findings

The project proposes to resurface segments of Datil Road and Sierra Del Sol. Additionally, the project proposes necessary safety improvements such as reconstruction of driveways, mountable dike and placement of safety edge on shoulder backing. This proposed project is exempt from CEQA under Section 15301 (c) because the resurfacing of the roadways does not create additional traffic lanes and involves negligible or no expansion of existing or former use of the existing roadway and associated facilities.

Impact on Citizens and Businesses

The purpose of this project is to rehabilitate deteriorated segments of Datil Road and Sierra Del Sol, totaling approximately one mile, to provide the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

The work is scheduled to begin in Spring of 2020. The work will be phased to keep the road open during construction as much as possible and will take approximately one month to complete.

Additional Fiscal Information

The construction contract is estimated to cost approximately \$850,285 and improvements will be funded with Gas Tax/SB-1 funds.



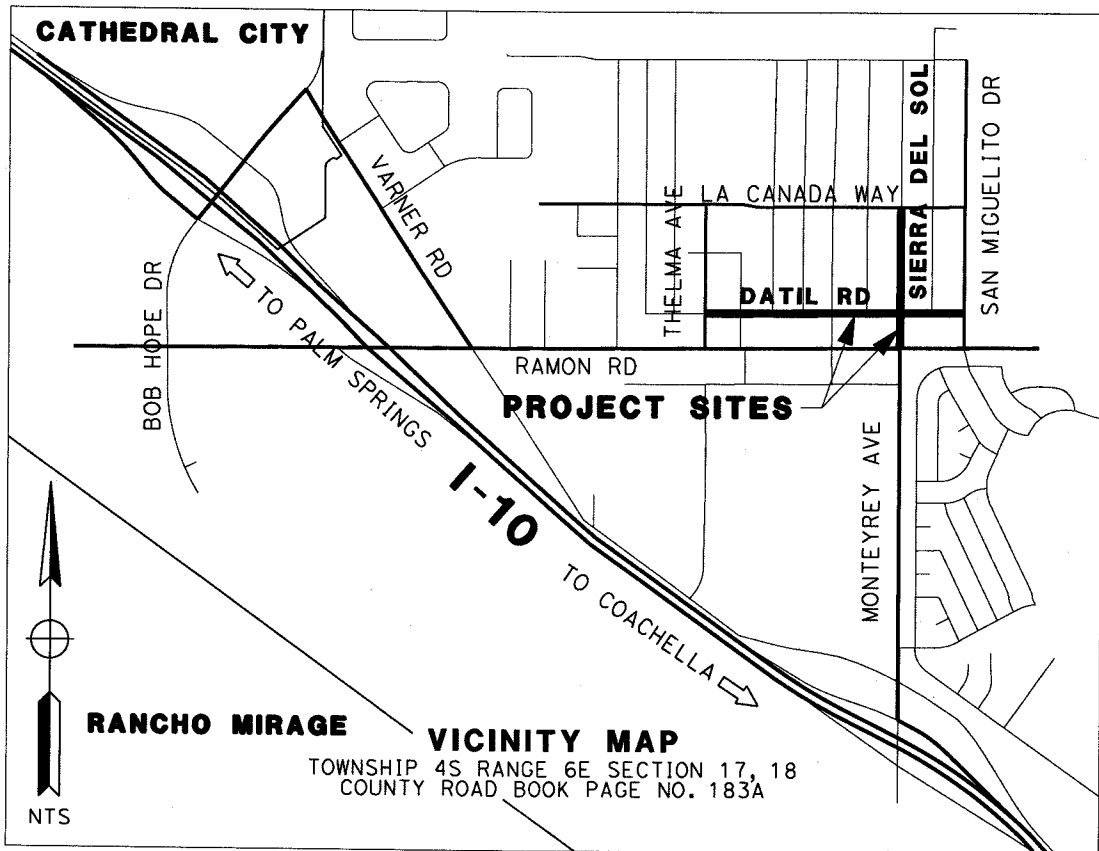
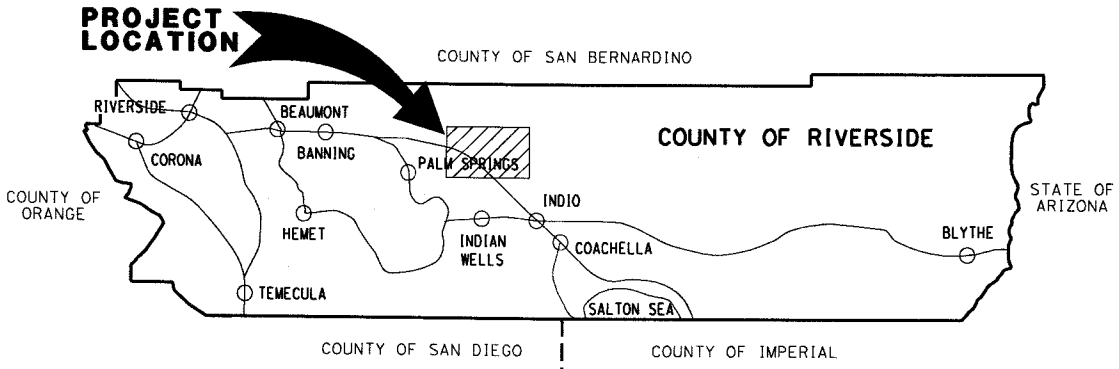

PROJECT DESCRIPTION: The County of Riverside Transportation Department is proposing to resurface approximately 0.5 miles of Datil Road from Thelma Avenue to San Miguelito Drive and approximately 0.25 miles of Sierra Del Sol from Ramon Road to La Canada Way. Datil Road currently ranges from 30-34 feet wide with curb and gutter along various segments of the roadway, and is classified as a local street in the County of Riverside's General Plan. Sierra Del Sol currently ranges from 26-72 feet wide with dike, curb and gutter along various segments of the roadway, and is classified as a local street in the County of Riverside's General Plan.

The proposed project will include the following:

- Construction/Reconstruction of asphalt concrete driveways, concrete driveways, and concrete curb ramp
- Pulverizing existing asphalt and overlay with Hot Mix Asphalt
- Placement of safety edge, shoulder backing, and asphalt concrete apron
- Salvage/Removal and installation of new signs
- Reconstruction of asphalt concrete mountable dike
- Roadway reconstruction at localized areas
- Roadway striping
- Utility Adjustments

ENVIRONMENTAL ANALYSIS:

The proposed project will be constructed within existing County right of way. Temporary construction easements may be required for the proposed improvements.

This project is subject to compliance with the Coachella Valley Multiple Species Habitat Conservation Plan (MSHCP). In accordance with Section 7.1 of the Coachella Valley MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity.

If tree or vegetation removal takes place during the migratory bird breeding season from March 1 to September 1, a pre-construction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act (MBTA).

The Riverside County Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:

Section 15301 (c) – Existing Facilities – The project proposes to resurface segments of Datil Rd & Sierra Del Sol. Additionally the project proposes necessary safety improvements such as reconstruction of driveways/mountable dike and placement of safety edge on shoulder backing. This proposed project is exempt from CEQA under Section 15301 (c) because the resurfacing of the roadways does not create additional traffic lanes and involves negligible or no expansion of existing or former use of the existing roadway and associated facilities.
