#### **BACKGROUND:**

#### **Summary**

On July 21, 2015, Agenda Items 3.43 and 3.62 were approved by the Board of Supervisors, with strict limitations to dollar amounts for various Agreement types with specific delegation of signature authority. The approval of Resolution 2016-157 which Authorized the Purchasing Agent to Initialize and Implement Public Contract Code Section 20131, subsection (c), for Procurement not to Exceed \$750,000 per Vendor Per Twelve Month Period was renewed and approved by the Board on July 12, 2016, Agenda Item 3-29, and then again on July 11, 2017, Agenda Item 3.42.

On June 18, 2019, Agenda Item #3.20, the Board adopted Resolution No. 2019-147 to authorize the Purchasing Agent to make procurements not to exceed \$750,000 per vendor related to County hospital and community health centers procurement procedures and activities until June 30, 2021.

Riverside University Health System-Medical Center's and the Community Health Centers' primary objective was to reduce the time normally required to finalize an Agreement. Typical Agreements might provide equipment for patient service, initiate student internships, or generate new net revenue. In each case, there is a sizable benefit to expediting the approval process. The secondary objective was to remove items that are repetitive or routine and thus, help declutter the Board's agenda.

Riverside University Health System (RUHS) continues to report Agreements and purchases approved under the specific delegated authority. Incorporated into this Board action is a report of all the Agreements and purchases approved during the First (1st) Quarter of Fiscal Year 2019/2020.

#### **Impact on Citizens and Businesses**

Delegated authority allows for patient services to be delivered faster and more efficiently. Those Agreements that increase revenue or accelerate payments improve the hospital's fiscal health.
