**BACKGROUND:**

**Summary**

Red flag warning for critical fire conditions began on October 29, 2019, prompting possible Public Safety Power Shutoffs in different areas of Riverside County and throughout California. The County/Operational Area Emergency Operations Center (EOC) was activated to monitor the impacts of possible wide-spread power shut-offs and coordinate support efforts for public safety response. In preparation for the dangerous fire conditions, the Riverside County Fire Department and partner public safety agencies augmented resources across the County. During the day of October 30th, due to the extreme winds and dry conditions, several fires broke out, impacting numerous communities across Western Riverside County. Evacuation orders were issued for the communities of Nuevo, Jurupa Valley and other surrounding areas. These conditions of extreme peril necessitated the proclamation of a local emergency by the Director of Emergency Services, which was ratified by the Board of Supervisors at their meeting of November 5, 2019.

It is requested that the Board of Supervisors adopt Resolution No. 2020-029 to terminate the Proclamation of Local Emergency. Many residents of Western Riverside County were impacted by the fire and its aftermath, which necessitated resources from both State and local entities. The situation resulting from said conditions of extreme peril is now deemed to be within the control of the normal protective services, personnel, equipment, and facilities of and within the County of Riverside.

15 personnel, equipment, and facilities of and within the County of Riverside; now, therefore,


16 IT IS HEREBY PROCLAIMED AND ORDERED by the Board of Supervisors of the
