**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. **Fair Housing Council of Riverside County, Inc. - \$1,000** funding will be used to support the 2020 Housing Conference. This conference will bring together decision-makers in order to solve Fair Housing issues in Riverside County.
2. **League of United Latin American Citizens of Riverside Council - \$1,500** funds will be used to assist the 9th Annual Free Community Health Fair. At this event, located in the 1<sup>st</sup> District, participants will receive free dental, vision and medical services. Up to 1,500 participants are expected to attend.
3. **Dresses & Dreams Project - \$1,000** funding will be used to support efforts to provide dresses to local high school girls that are going through hardships or circumstances which leave them unable to purchase a formal dress and accessories to attend their prom. 150-175 girls are expected to sign for assistance this year.
4. **Riverside Life Services - \$1,000** funding will be used to provide prenatal counseling, classes and resources to women in need.
