The Department of Homeland Security (DHS) has awarded Riverside County Fire Department the FY18 Assistance to Firefighters Grant (AFG) Award No. EMW-2018-FO-03784 in the amount of \$547,106.95 to purchase and install Source Capture Exhaust Systems (SCES) in multiple Riverside County owned and operated fire stations. This grant award addresses the risks posed by exposure to diesel fumes, and the SCES are an AFG High Priority item for vehicle exhaust mitigation under Modification to Facilities, as noted in the grants Fiscal Year 2018 Assistance to Firefighters Grants Notice of Funding Opportunity document. An SCES is a system where exhaust gases from a vehicle are captured directly, via a conduit that attaches to/over the end of the vehicle's exhaust system at the tailpipe. The captured exhaust gases are expelled through the attached conduit via mechanical/pneumatic means to the exterior of the building.

In compliance with Board of Supervisors Policy A-30 (Coordination of Grants), Board of Supervisors action on October 23, 2018 (3.23) granted the Fire Department authorization to proceed with the pre-application and the obligated County funds are specifically budgeted in the current fiscal year. In addition, this grant pertains to the function of the Fire Department.

The purpose of the AFG program is to enhance the safety of the public and firefighters with respect to fire and fire-related hazards. The program provides direct financial assistance to fire departments for critically needed resources to equip and train emergency personnel to recognized standards, enhance operational efficiencies, foster interoperability, and support community resilience.

A budget adjustment is attached for approval (Schedule A) for the grant funding only. It has been reviewed and approved by the Auditor-Controller. The cash match is already budgeted for FY 19/20.

A budget adjustment for the grant funding only for FY 19/20. No additional General Funds are requested.

The performance period spans two fiscal years and the expectation is to fully expend these funds in FY 19/20 prior to the end of the period, and no funds have been expended in FY 19/20. Therefore, the Department is requesting a budget adjustment for FY 19/20.

On June 23, 2017, the department was awarded \$364,375 to purchase ruggedized tables for several medic apparatuses in support of our Electronic Patient Care Reports (EPCR) program. The Board of Supervisors action on August 29, 2017 (3-67) authorized the acceptance of the grant and the terms of the grant are currently being performed.

On June 22, 2015, the department was awarded \$193,360 in AFG funding to purchase four (4) Self-Contained Breathing Apparatus fill stations. The Board of Supervisors action on August 18, 2015 (3-33) authorized the acceptance of the grant and the terms of the grant were satisfied.

Article 1 Assurances, Administrative Requirements, Cost Principles, Representations and Certifications

DHS financial assistance recipients must complete either the Office of Management and Budget(OMB) Standard Form 424B Assurances - Non-Construction Programs, or OMB Standard Form 424D Assurances -Construction Programs as applicable. Article 10 Copyright

Article 11 Debarment and Suspension

Article 14 Education Amendments of 1972 (Equal Opportunity in Education Act) – Title IX

Recipients must comply with the requirements of Title IX of the Education Amendments of 1972 Pub. L. No. 92-318 (1972) (codified as amended at 20 U.S.C. § 1681 et seq.), which provide that no person in the United States will, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any educational program or activity receiving federal financial assistance. DHS implementing regulations are codified at 6 C.F.R. Part 17 and 44 C.F.R. Part 19.

Article 15 Energy Policy and Conservation Act

Recipients must comply with the requirements of The Energy Policy and Conservation Act Pub. L. No. 94- 163 (1975) (codified as amended at 42 U.S.C. § 6201 et seq.), which contain policies relating to energy efficiency that are defined in the state energy conservation plan issued in compliance with this Act.

Article 16 False Claims Act and Program Fraud Civil Remedies

Article 20 Hotel and Motel Fire Safety Act of 1990

In accordance with Section 6 of the Hotel and Motel Fire Safety Act of 1990, 15 U.S.C. § 2225a, recipients must ensure that all conference, meeting, convention, or training space funded in whole or in part with federal funds complies with the fire prevention and control guidelines of the Federal Fire Prevention and Control Act of 1974, codified as amended at 15 U.S.C. § 2225.

Article 21 Limited English Proficiency (Civil Rights Act of 1964, Title VI)
Recipients must comply with the Title VI of the Civil Rights Act of 1964 (42 U.S.C. § 2000d et seq.) prohibition against discrimination on the basis of national origin, which requires that recipients of federal financial assistance take reasonable steps to provide meaningful access to persons with limited English proficiency (LEP) to their programs and services. Article 22 Lobbying Prohibitions

The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 C.F.R. Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition.

Article 29 Rehabilitation Act of 1973

Recipients must comply with the requirements of Section 504 of the Rehabilitation Act of 1973, Pub. L. No. 93-112 (1973) (codified as amended at 29 U.S.C. § 794), which provides that no otherwise qualified handicapped individuals in the United States will, solely by reason of the handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.

Article 30 Reporting of Matters Related to Recipient Integrity and Performance
