

**BACKGROUND:**

**Summary**

The Riverside County Transportation Department (Transportation Department) is moving forward to implement off-site mitigation in accordance with the permit requirements of the State Route 79 (Winchester Road) Widening Project, Interstate 15 at Clinton Keith Road Interchange Improvement Project, Clinton Keith Extension Project, and the State Route 371 (SR-371) Shoulder Widening project.

The Integrated Mitigation Project site is located south of Scott Road and west of Briggs Road. It is owned by the Western Riverside County Regional Conservation Authority (RCA) and consists of roughly 74 acres.

The Board of Supervisors has previously approved and authorized the Transportation Department to advertise and solicit pre-qualification bids on October 25, 2016 (Agenda Item 3-23). The contract advertisement and award process was postponed to provide for revised construction plans and specifications.

On December 10, 2019, (Agenda Item 3.47) the Board of Supervisors approved re-advertisement to solicit Pre-Qualification of Licensed Contractors registered with the state of California and holding a Contractor’s License type C-27 (Landscaping).

During the advertisement, period two addenda were issued as a supplement to the pre-qualification requirements. The addenda are attached and designated as Addendum No. 1 and Addendum No.2.

On January 15, 2020, five pre-qualification applications were received from potential contractors who could work on this project. All five application were accepted and contractors were determined to be qualified for this project. The following are the companies whose applications are recommended to be approved and allowed to bid on this project:

1. Griffith Company
2. Hanford Applied Restoration & Conservation
3. Natures Image Inc.
4. Helix Environmental Planning, Inc.
5. Pacific Restoration Group, Inc.

The construction contract will be advertised and the Transportation Department will obtain bids from the five Pre-Qualified companies. The contractor selection will be based upon the lowest responsive and responsible bid of the sum of all bid schedules.

The bid documents include the following bid schedules of work:

Base Bid Schedule A:	Briggs Road Channel Construction
Base Bid Schedule B:	Briggs Road Landscape, Irrigation and Plant Establishment
Base Bid Schedule C:	Clinton Keith Road Restoration and Enhancement
Base Bid Schedule D:	Clinton Keith Road Plant Establishment

The awarded contractor will construct a new stream channel and seasonal wetlands, enhance the streambed, and preserve existing habitat for specific habitat losses that resulted from the projects mentioned above.

The submitted plans and specifications have been approved as to form by County Counsel.

**Environmental Findings**

On October 25, 2016 (Agenda Item 3-23), the proposed Integrated Mitigation Project was reviewed and determined by the Board of Supervisors that nothing further is required under CEQA because all potentially significant effects have been fully analyzed in the earlier environmental documents for the Clinton Keith Extension Project, State Route 79 Widening Project and Interstate 15/Clinton Keith Road Interchange Project and has been documented in a Notice of Determination.

To ensure sufficient irrigation for the integrated mitigation project, a waterline will be extended. This action is exempt from CEQA under Section 21080.21 because the project consists of installation of a water line less than one mile in length within a public street and right-of-way. The project is also exempt under Section 15301 (Existing Facilities) Class 1 because the project proposes a minor alteration of an existing public facility that involves negligible expansion of use.

**Impact on Residents and Businesses**

The project will restore and enhance the RCA conservation land by:

- Increasing native vegetation and habitat for dependent flora and fauna within the watershed,
- Increasing soil moisture retention,
- Removing non-native plants,
- Decreasing erosion, and
- Reducing downstream flooding.

These improvements will enhance water quality in the watershed and biological efficacy, and ultimately restore and protect the environment for local residents and future generations.

The work is scheduled to begin in Summer 2020 and will take approximately five months to complete and will be followed by a five year monitoring and plant establishment maintenance period.

The construction contract is estimated to cost approximately \$1,273,498. The Integrated Mitigation Project construction contract will be funded with Measure A – Western and Combined Improvement Funds. There are no General Funds used in this project.
