Arlo was born in in Kearney, Nebraska on July 13, 1925. He was raised as an only child to Gladys and Herbert Gard. In 1942 at 17 years of age, Arlo enlisted in the United States Marine Corps. Assigned to the 3<sup>rd</sup> Marine Division, 12<sup>th</sup> Marine Regiment. Arlo saw combat action on the islands of Bougainville, Iwo Jima and Guam. He remained very proud of his Marine Corp heritage, displaying the Corps flag at his house daily. At the conclusion of WWII, Arlo returned to Kearney and attended Kearney State Teacher's College where he earned his bachelor's degree in Physical Education. He played football, basketball and track, and met his future wife Kathryn Powell. Later Arlo earned his master's degree in Educational Guidance at the University of Wyoming.

Arlo and Kathryn moved to California, where Arlo began his 33-year career with the Riverside Unified School District. Arlo first taught at University Heights Junior High School. Then moved on to open Rubidoux High School. In 1966 Arlo moved to Riverside Poly High School where he spent the remainder of his career. Arlo coached many sports and a multitude of athletes over the course of 39 years. He earned many coaching awards for his exemplary service. Arlo was inducted into the Kearney State Hall of Fame as well as the Riverside Hall of Fame. He was well known for his great ability to tell stories of former players and specific events from games long forgotten by others.

Arlo was an avid golfer, and in his later years became very active at the Janet Goeske Center, playing bridge and coaching one of the pool teams. Arlo was preceded in death by his wife Kathryn Powell, who passed away in 2012.

John was born April 17, 1935 in Great Falls, Montana. His late father and mother, Fred and Ruth Ferguson, resided in Riverside for nearly sixty years.

Kirk graduated from Riverside Poly High School in 1953. He was a Charter Student at the University of California Riverside when the campus opened in February 1954. He graduated with a B.A. degree in June 1957. Kirk enlisted in the U.S. Naval Reserve, and after graduating from UCR and the U.S. Naval Officer Candidate School in Newport, Rhode Island, he received a commission in the U.S. Navy, and retired with the rank of Commander.

Kirk earned sixteen service ribbons and medals, which include the Bronze Star Medal with the Combat "V" device for Valor and the Combat Action Ribbon. He was also the 1989 President of the Riverside March Field Chapter of the Military Officers Association of America. Following retirement from the U.S. Navy in 1981, Kirk worked for General Dynamics as a Design Engineer for the Standard Missile Department at their Pomona, California division until his retirement in 1990. He has written enumerable U.S. Navy oriented magazine articles, conducted oral histories of World War II Navy veterans, and appeared in History Channel videos. Kirk was a Master Mason and Life Member of Riverside Lodge # 635, F.&A.M; Riverside Chapter #622, Order of the Eastern Star; 32<sup>nd</sup> Degree Scottish Rite Mason; Order of the Nobles of the Mystic Shrine, the world's largest fraternal philanthropy.
