SUMMARY OF ORDINANCE NO. 555.20 AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 555, THE ORDINANCE OF THE COUNTY OF RIVERSIDE IMPLEMENTING THE SURFACE MINING AND RECLAMATION ACT OF 1975 ("SMARA")

This summary is presented pursuant to California Government Code Section 25124(b): a certified copy of the full text of Ordinance No. 555.20 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside, located at 4080 Lemon Street, 1st Floor, Riverside, California.

Ordinance No. 555.20 amends Ordinance No. 555 in its entirety and replaces it with new language that updates procedures for processing mining-related applications and related filings; establishes a new mining administrative fee; updates other fees, including setting forth new requirements for initial deposit amounts for deposit-based fees associated with mining applications and mining inspections; makes the mining-related fee amounts set forth in Ordinance No. 555 capable of being amended by resolution in the future; updates, streamlines, and clarifies the County's administrative processing procedures relating to mining applications and permits and carrying out SMARA requirements; and updates terminology and requirements to reflect current state law. Ordinance No. 555.20 would take effect 60 days after its adoption.

SUMMARY OF ORDINANCE NO. 955 AN ORDINANCE OF THE COUNTY OF RIVERSIDE AUTHORIZING THE LEVY OF A SPECIAL TAX WITHIN COMMUNI- TY FACILITIES DISTRICT NO. 19-2M (WINCHESTER RANCH) OF THE COUNTY OF RIVERSIDE

This summary is presented pursuant to California Government Code Section 25124(b). A certified copy of the full text of Ordinance No. 955 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside, located at 4080 Lemon Street 1st Floor, Riverside, California 92501.

Pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, commencing with Section 53311 of the California Government Code (the "Government Code"), October 8, 2019 the Board of Supervisors (the "Board of Supervisors") of the County of Riverside adopted Resolution No. 2019-190, stating its intention to establish a community facilities district proposed to be named Community Facilities District No. 19-2M (Winchester Ranch) of the County of Riverside (the "District"), and to authorize the levy of special taxes to fund, pay for, and finance authorized lighting and maintenance services for streets, roads, parks, parkways and open space (the "Services") and to pay expenses incidental thereto and incidental to the levy and collection of the special taxes, so long as the special taxes are needed to fund the Services.

Ordinance No. 955 authorizes the levy of special taxes within the District at the rate and in accordance with the method of apportionment approved by the voters at an election held on November 19, 2019 regarding the proposed levy of special taxes. Ordinance No. 955 provides that the Board of Supervisors, as the legislative body of the District, is authorized and directed each fiscal year to determine or cause to be determined the specific special tax rate and amount to be levied for the next ensuing fiscal year for each parcel of real property within the District. The special tax revenues shall be used to fund, pay for, and finance the Services and shall be levied so long as special taxes are needed to fund such Services. In addition, the special tax revenue may be used to replenish a reserve fund for the District, to pay the costs of administering the District, and to fund the cost of collecting and administering the special tax. Ordinance No. 955 provides that the special taxes may be collected on the secured property tax roll in the same manner as ordinary ad valorem taxes and that the special taxes shall have the same lien priority, and be subject to the same penalties and the same procedure and sale in cases of delinquency as provided for ad valorem taxes. The rate and method of apportionment of the special tax authorized by Ordinance No. 955 is the rate and method approved by voters within the District and as further reflected in Exhibit A "Rate and Method" to Ordinance No. 955. A complete copy of Exhibit A "Rate and Method" is on file with the Clerk of the Board of Supervisors and is available for public inspection and copying in that office in accordance with the California Public Records Act, Chapter 3.5 (commencing with Section 6250) of Division 7 of Title 1 of the Government Code. Ordinance No. 955 takes effect immediately upon its adoption in accordance with section 25123(c) of the Government Code.
