

BACKGROUND:

The Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the members must come from the business community. In addition, WDBs are required to have representation from local community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two-year terms.

Ms. Darlene Wetton's extensive experience in healthcare management has played an important role for the WDB. Under Ms. Wetton's leadership, Temecula Valley Hospital has been honored as one of the select hospitals across the nation to achieve a five-star designation with Centers for Medicare and Medicaid Services. She provides insight to address the workforce needs of the healthcare sector, an in-demand industry identified by the WDB. Her membership on the WDB not only brings the perspective of a healthcare industry expert, but also that of a large employer in the region. Ms. Wetton's continuing membership will help further the WDB's efforts to address

workforce needs in the healthcare sector and increase opportunities for partnerships with businesses, community-based organizations, and educational institutions.
