Havens M.D. Jr., who passed away on May 1, 2020, at the age of 98 in Riverside, California where he lived for 67 years.

Fred was born February 10, 1922 in Milwaukee, Wisconsin, to Dr. Fred Z. Havens, Sr. and Clara Hazel (Reed) Havens. He attended college and medical school at the University of Minnesota and received his M.D. degree at the age of 23. He joined the U.S. Navy and served for nearly two years at the American Consulate in Shanghai, China as Lieutenant JG followed by several years post-war in the reserves. Upon returning to the States he completed specialty training in Internal Medicine and earned an M.S. Degree in Hematology from University of Minnesota. Like his father, he began practicing medicine at the Mayo Clinic, where he also met his future wife Barbara.

In 1953 Fred, his wife, their newborn and their cat Pogo moved to Riverside California. There he joined the Riverside Medical Clinic with some of his Mayo colleagues, and became the eighth physician to join the staff, first in the Mission Inn Rotunda, and later at a new Clinic building on Arlington Avenue.

Fred dedicated 55 years of medical service to the community before retiring at age 86. During those years, he was both a committed advocate for public health and an empathetic country doctor who made house calls for those who couldn't make it to his office for treatment. He also trained interns at Riverside General Hospital. He served on the Clinic Board of Directors, was President of the Heart Association and Co-Director of the Substance Abuse Treatment Center at Knollwood hospital. As a member of the Clinical Faculty of Medical Geosciences, he later taught pre-med students at UCR how to successfully diagnose and treat their future patients.

Fred enjoyed deep sea fishing, playing bridge, gardening, watching the horse races at Del Mar and golfing at the Victoria Club, where he was a member since 1957. He also loved spending time in Carlsbad, California with friends and family.

Fred's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.

Bob was born October 10, 1929 to Bert and Hazel Umphress, in Colfax, Iowa. After graduating from Colfax High School, instead of accepting a college football scholarship, Bob enlisted in the U.S. Army. Following his military service during the Korean War, he attended the University of Illinois. After his first year of college, Bob decided he wanted a change from the Midwest. He moved westward, to attend the University of Hawaii, in Honolulu. There, he majored in Economics. During his time at University of Hawaii, Bob became the only 3 semester Editor of The Ka Leo campus newspaper. He developed quite a reputation as a bold, daring, but honest writer. Bob was accepted into the honorary academic fraternity Omicron Delta Kappa and graduated among the top 10 outstanding students. After graduating, Bob fulfilled three years of military service as a captain in the U.S. Army.

Bob Accepted a scholarship to attend Stanford University, where he earned his master's degree in journalism. He stayed in the Bay Area, where he received The Solver Spindle Award for a series he did on social issues, while working for the San Mateo Times. Later, he worked for the Oakland Tribune and the Stars and Stripes Newspaper. After six years working for the Stars and Stripes in Germany, Bob and his young family returned to the US where he worked for the Riverside Press Enterprise for 8 years, as a journalist and editor. Then he started his own weekly community newspaper, "Jurupa This Week." He was the publisher, journalist, photographer and editor, from February 1, 1984 to his last edition on June 27, 1997.

Bob was best known for his integrity, in life and in his writings. In the Jurupa area, he was a member of the Chamber of Commerce, American Legion Post 500 and VFW Post 10267. He also served on the Veteran's Wall Memorial Board, Jurupa Community citizens Patrol and Jurupa Cultural Center Board.
