BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- The Joslyn Center provides health, recreational, educational and social programs along with information, referral volunteer and support services for adults age 50 and older. Funds will help with the process of introducing acting classes and small communitybased productions to the Arthur Newman Theater.
- 2. Angel View, Inc. is a non-profit organization supporting a wide range of services to children and adults with disabilities to help them reach their maximum potential. These services includes residential nursing care, therapeutic day programs and family stabilization case management. CID funds will be used to help offset fees paid to Old Town Artisan Studios and Susan Lake for providing Art Therapy to clients of Angel View's Day Program (art and dance).
- 3. Digicom Learning provides a productive and creative outlet in which youth learn how to use digital storytelling to better understand themselves, their schoolwork, and the world around them. CID funds will be used to help cover the costs of launching the student club, also paid internships for those who were trained by Digicom in their K-12 programs.
- 4. Voices for Children provides a Court Appointed Special Advocate (CASA) for foster children in Riverside County. CASA advocates for the rights and well-being of children, from newborn to 21 years, and provides support that they need to thrive in life. CID funding will be used to help fund advocacy supervisors, which maintain a caseload of 45-55 volunteers.
- 5. Boys and Girls Club of the Coachella Valley offer the Boxing Athletics program at two facilities: Indio and Mecca. The program serves youth and young adults that are involved in, or at-risk of becoming involved in juvenile delinquent behavior such as gang activity, substance abuse, physical aggression and school suspensions. Funds will help fund staff and program equipment.
- The Boys and Girls Club of Cathedral City offers the Triple Play Healthy Habits program, which includes healthy habits nutritional curriculum, daily challenges, sports clubs, triple play games, intergeneration garden and social recreation. Funds will help offset costs associated with the program.
- 7. Senator Robert Presley Scholarship fund provides scholarship support to UCR students who wish to pursue academic and research activities in the Presley Center of Crime and Justice Studies.

- 8. Read with Me Volunteer Programs is a non-profit organization that provide assistance to children in the poorest geographic area of the desert so that they may develop to their maximum potential by learning how to read, comprehend and speak English and know that people care about them as individuals. Funding will help cover costs of individual tutoring at Peter Pendleton School in Coachella.
- 9. Mission Veteran provide Veterans and family members support through educational, recreational, and social activities. Mission Veteran offers a music program that provides Veterans an outlet for stress, trauma and other service related obstacles through group and individual music lessons. They also offer a retreat for Veteran in individual and spousal settings. Funds will offset cost of travel, lodging, food and activities; also provide resources for musical instruments and accessories.
- 10. The American Outreach Foundation is a non-profit organization that provides electric wheelchairs and scooters, in perfect condition to veterans, low-income seniors and those who do not have insurance or those whose health insurance policy does not cover this type of assistance. CID funds will be utilized to help cover the cost of pickup/ delivery of power chairs, batteries and other program costs.
- 11. ABC Recovery Center provides an environment for alcoholics and drug addicts to achieve lifelong sobriety and re-enter the community. Funds will help cover the costs for veterans who need help with housing.
- 12. The Health Assessment and Research for Communities (HARC) mission is to provide objective reliable research, analysis and technical service of health needs to the Coachella Valley. HARC conducts a community-wide survey of the health and well-being topics, such as health access, utilization, behaviors, major disease, mental health, and more. Results are provided to the community at no charge. CID funding will help enable to retain questions about veterans.
- 13. Coachella Valley Rescue Mission provides food, shelter, clothing, counseling, and case management services for individuals who are homeless and displaced. CVRM Emergency Services program operates 24 hours a day which includes overnight shelters. CID funds will be utilized towards their Emergency Services for Homeless Veterans throughout the Coachella Valley.
- 14. The American Legion District 21 produces The Legionnaire Newspaper, which provides readers with up to date information regarding post activities, vital veteran issues and information regarding special events. The newspaper helps support programs such as; widows assistance fund, child welfare assistance, post rehabilitation for veterans and the American Legion baseball outreach. CID funds will be used to support the newspaper and these programs.
- 15. The Coachella Valley Horse Rescue offers the Horsinalities Veterans Boot Camp, in an effort to help veterans and horses regain their inner strength, confidence, and trust while going through obstacle courses and participating in various drills and exercises led by a

- certified horse professional. The CID funds will help cover the costs of offering the program twice a week.
- 16. Desert Hot Springs Community Task Force has provided homeless shelter for adults in the western end of the Coachella Valley. Shea's Veterans Center benefits those who lack housing and provide much needed emergency shelter relief services, counseling referrals, and support for sober living. CID funds will be utilized to supplement the rent for any veteran who cannot afford to pay rent.
- 17. The Spay Neuter Imperative Project (SNIP) Bus is a low-income mobile spay and neuter clinic and has provided nearly 15,000 surgeries to dogs and cats. CID funds will help cover costs of clinics in the 4th District.
- 18. CVAG's Homelessness Committee enters in its 12th year of managing the Alan Seman Bus Pass Program. The program distributes passes to non-profit agencies throughout the Coachella Valley, which provides homeless, or near homeless individual's transportation to and from services such as DMV, medical appointments, mental health, social and court services etc. CID funding will be utilized to purchase the bus passes.
- 19. Coachella Valley Repertory (CVRep) is an educational, dramatic and musical theater organization that was established in 2008. In 2018, the company purchased the former IMAX Theater in Cathedral City. CVRep will purchase two AED defibrillators; CID funds will help cover the costs of training for staff and volunteers.
- 20. The Riverside County Fair & National Date Festival collaborated with Riverside County Animal Services for the seventh year to host dog adoptions during the Fair. Animal Services educate and are exposed to approximately 270,000 people in 10 days, allowing for hundreds of adoptions that might not otherwise take place in the shelters. It helps alleviate the dog population in the shelters and provides these animals a second chance. The CID funds will allow the Fair to offset the cost of the tent required to house the animals up for adoption.
- 21. World Affairs Council of the Desert sponsors the Porter Academic World Quest program, an educational and learning competition testing high school students' knowledge of international affairs. Additionally, the World Affairs Council will invite high school and college students from the Coachella Valley to attend the monthly Speaker Dinner Series. CID Funds will be utilized to support the Academic World Quest Competition.
- 22. The Regional Access Project (RAP) Foundation serves as the fiscal agent for the scholarship fund for the Fourth District Youth Advisory Council (YAC). YAC members are high school students who participate in monthly community and county service projects in the Fourth District. CID funds will go to the RAP foundation to support the scholarship fund.
