BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the May 05, 2015 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 18, 2015. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 22, 2015 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

Revenue and Taxation Code 4676 (b) states that the county shall make reasonable effort to obtain the name and last known mailing address of the parties of interest. Then, if the address of the party of interest cannot be obtained, the county shall publish notice of the right to claim excess proceeds in a newspaper of general circulation in the county as per Revenue and Taxation Code 4676 (c). The Treasurer-Tax Collector's Office has made it a policy to take the following actions to locate the rightful party of the excess proceeds.

- 1. Examined title reports to notify all parties of interest attached to the parcel.
- 2. Researched all last assessee's through the County's Property Tax System for any additional addresses.
- 3. Used Accurint (people finder) to notify any new addresses that may be listed for our last assessees.
- Advertised in newspapers for three consecutive weeks in the Desert Sun, Palo Verde Valley Times and the Press Enterprise referring any parties of interest to file a claim for the excess proceeds.
- 5. Sent out a certified mailing within 90 days as required by Revenue and Taxation Code 4676(b).

According to Revenue and Taxation Code 4675 (a) Any party of interest in the property may file with the county a claim for the excess proceeds, in proportion to his or her interest held with others of equal priority in the property at the time of the sale, at any time prior to the expiration of the one year following the recordation of the Tax Collector's deed to the Purchaser, which was recorded on June 18, 2015.

The Treasurer-Tax Collector has received four claims for excess proceeds:

- 1. Claim from Craland Recoveries, Inc., authorized agent for Janet Rae Burrows, Executor of the Estate of the late S. Douglas Burrows, AKA Sherman Douglas Burrows AKA Sherman D. Burrows based on an Authorization for Agent to Collect dated May 12, 2016 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663, Certificate of Death for Sherman Douglas Burrows, Letters Testamentary filed May 10, 1989 in Case No. A148053 of the Orange County Superior Court, and a marriage certificate for Sherman Douglas Burrows and Janet Rae Corey.
- Claim from Craland Recoveries, Inc., authorized agent for Richard W. Kelner based on an Authorization for Agent to Collect dated October 01, 2015 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663.
- Claim from Craland Recoveries, Inc., authorized agent for George E. Garr based on an Authorization for Agent to Collect dated November 02, 2015 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663.
- Claim from Craland Recoveries, Inc., authorized agent for Vernal Edward Farrar based on an Authorization for Agent to Collect dated October 26, 2015 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Craland Recoveries, Inc., authorized agent for Janet Rae Burrows, Executor of the Estate of the late S. Douglas Burrows, AKA Sherman Douglas Burrows AKA Sherman D. Burrows be awarded excess proceeds in the amount of \$20,860.73, Craland Recoveries, Inc., authorized agent for Richard W. Kelner be awarded excess proceeds in the amount of \$20,860.73, Craland Recoveries, Inc., authorized agent for George E. Garr be awarded excess proceeds in the amount of \$20,860.73 and the claim of Craland Recoveries,

Inc., authorized agent for Vernal Edward Farrar be denied since they were not able to substantiate their claim. Since there are no other claimants, the unclaimed excess proceeds in the amount of \$41,721.48 will be transferred to the county general fund. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

Impact on Residents and Businesses

Excess proceeds are being released to last assessees and to the County General Fund.

BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the May 05, 2015 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 18, 2015. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 22, 2015 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

Revenue and Taxation Code 4676 (b) states that the county shall make reasonable effort to obtain the name and last known mailing address of the parties of interest. Then, if the address of the party of interest cannot be obtained, the county shall publish notice of the right to claim excess proceeds in a newspaper of general circulation in the county as per Revenue and Taxation Code 4676 (c). The Treasurer-Tax Collector's Office has made it a policy to take the following actions to locate the rightful party of the excess proceeds.

- 1. Examined title reports to notify all parties of interest attached to the parcel.
- 2. Researched all last assessee's through the County's Property Tax System for any additional addresses.
- 3. Used Accurint (people finder) to notify any new addresses that may be listed for our last assessees.
- Advertised in newspapers for three consecutive weeks in the Desert Sun, Palo Verde Valley Times and the Press Enterprise referring any parties of interest to file a claim for the excess proceeds.
- 5. Sent out a certified mailing within 90 days as required by Revenue and Taxation Code 4676(b).

According to Revenue and Taxation Code 4675 (a) Any party of interest in the property may file with the county a claim for the excess proceeds, in proportion to his or her interest held with others of equal priority in the property at the time of the sale, at any time prior to the expiration of the one year following the recordation of the Tax Collector's deed to the Purchaser, which was recorded on June 18, 2015.

The Treasurer-Tax Collector has received four claims for excess proceeds:

- 1. Claim from Craland Recoveries, Inc., authorized agent for Janet Rae Burrows, Executor of the Estate of the late S. Douglas Burrows, AKA Sherman Douglas Burrows AKA Sherman D. Burrows based on an Authorization for Agent to Collect dated May 12, 2016 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663, Certificate of Death for Sherman Douglas Burrows, Letters Testamentary filed May 10, 1989 in Case No. A148053 of the Orange County Superior Court, and a marriage certificate for Sherman Douglas Burrows and Janet Rae Corey.
- 2. Claim from Craland Recoveries, Inc., authorized agent for Richard W. Kelner based on an Authorization for Agent to Collect dated October 01, 2015 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663.
- 3. Claim from Craland Recoveries, Inc., authorized agent for George E. Garr based on an Authorization for Agent to Collect dated November 02, 2015 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663.
- Claim from Craland Recoveries, Inc., authorized agent for Vernal Edward Farrar based on an Authorization for Agent to Collect dated October 26, 2015 and a Grant Deed recorded April 13, 1966 as Instrument No. 38663.

Douglas Burrows, AKA Sherman Douglas Burrows AKA Sherman D. Burrows be awarded excess proceeds in the amount of \$20,860.73, Craland Recoveries, Inc., authorized agent for Richard W. Kelner be awarded excess proceeds in the amount of \$20,860.73, Craland Recoveries, Inc., authorized agent for George E. Garr be awarded excess proceeds in the amount of \$20,860.73 and the claim of Craland Recoveries,

Inc., authorized agent for Vernal Edward Farrar be denied since they were not able to substantiate their claim. Since there are no other claimants, the unclaimed excess proceeds in the amount of \$41,721.48 will be transferred to the county general fund. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.


