SUBJECT: RIVERSIDE UNIVERSITY HEALTH SYSTEM-MEDICAL CENTER: Renewal of the Medically Indigent Services Program and Authorization of Payments to Vendors to provide Medical Services and Pharmaceuticals, effective July 1, 2020 through June 30, 2023; All Districts. [Total Cost \$15,000,000; Annual Cost \$5,000,000; 72% - State Health Realignment and 28% - General Fund]

RECOMMENDED MOTION: That the Board of Supervisors:

- Approve the renewal of the Medically Indigent Services Program (MISP) and authorize
 the MISP Director or designee, to administer the program and reimburse the vendors
 listed in Attachment A, MISP Vendor List, for medical services and pharmaceuticals, for
 three fiscal years effective July 1, 2020 through June 30, 2023, not to exceed an annual
 aggregate amount of \$5,000,000 per fiscal year; and
- Direct the MISP Program Director or designee to establish any necessary provider agreements pursuant to County standard procurement policies, procedures and authorities, subject to approval as to form by County Counsel.

BACKGROUND:

Summary

Riverside University Health Systems – Medical Center requests the Board of Supervisors approve the funding of the Medically Indigent Services Program (MISP) for three additional fiscal years and authorize the director to administer the program and pay the vendors (Attachment A, MISP Vendor List) that provide medical care, dental care and pharmaceuticals to the MISP population in Riverside County.

The MISP was born in Riverside County in 1983. The MISP is a program of last resort, a health care safety net, and the main source of health care for a specific population that do not meet Medi-Cal qualifications under the Affordable Care Act (ACA) Healthcare Reform. The program provides financial assistance to meet the health care needs of the adult population between the ages of 21-64. The qualified recipients of the program must meet the income requirements that place them in the Federal Poverty level range of 0-200%. The MISP is designed to cover acute illnesses and medical care. The intended goal is to prevent disability.

The MISP program administers payments to pharmacies, physician groups and hospitals for the medically indigent adult populations, juvenile correctional health populations, adult correctional health populations and managed care patients assigned to County providers in need of medical care and pharmaceuticals.

Impact on Residents and Businesses

The MISP can extend specialty and hospital care to the needs of the MISP population on a consistent basis. The ability to receive consistent health care has aided in the reduction of costly hospital admissions and a reduction in emergency room visits. The decrease in emergency room visits reduces extended wait time and allows for additional space to render services to all patient populations in need of emergent care. The provision of indigent medical services is a mandate by the State of California under the Welfare and Institutions (WIC) Code Section 17000 as a condition for receiving state realignment funding.

Additional Fiscal Information

MISP providers are reimbursed according to the State of California Medi-Cal Fee Schedule. Most medically indigent health care costs are offset by vehicle license revenue and state realignment sales tax.

Contract History and Price Reasonableness

On July 31, 2018, Agenda Item 3.37, the Board approved funding to administer the Medically Indigent Services Program (MISP) and authorized payments to vendors for medical services and pharmaceuticals for a period of three (3) fiscal years, beginning July 1, 2017 to June 30, 2020 for a total cost of \$15,000,000. MISP has utilized the Form 11 as a vehicle to request the necessary funding from the Board of Supervisors needed to pay health care providers since the origination of the program in 1987.
