As we prepare for our entry into the medical field, we watch as racial inequities continue to divide our country. At the center of this divide is the fight for human life. As future medical professionals, we will speak out against all forms of abuse that adversely affect the mental and physical health of American residents. In particular, we are horrified by the treatment of Black residents in this country by the very police officers who swore to protect and serve their communities. Not only do we recognize racism's contribution to the disproportionate criminalization and abuse of our Black communities, but as aspiring health professionals we understand how it affects the health outcomes for Black Americans. This is why we are asking the County of Riverside to declare racism a public health crisis, effective immediately.

From the earliest stages of life, Black Americans experience inequality in healthcare. In 2019, Dr. Jeffery Horbar et al. published a study finding that Neonatal Intensive Care Units throughout the United States are segregated by race and ethnicity. Furthermore, they report that Black preterm infants receive care at lower quality NICUs than other racial minorities, which they believe contributes to the high mortality rate of Black preterm babies. This lack of access to adequate healthcare continues throughout the life of Black Americans. Jha et al. finds that Black elderly patients receive care at hospitals with low quality markers, and in turn have high mortality rates for conditions such as acute myocardial infarction and pneumonia. Throughout their lives, Black Americans experience higher rates of obesity and hypertension. Black expectant mothers also have 3 to 4 times higher rates of mortality during childbirth when compared to White expectant mothers. Finally — and most recently— the COVID-19 pandemic has had a greater impact on Black communities across the United States than on any other racial or ethnic group.

The County of Riverside is no exception to this reality. Although Riverside County and the State have taken steps to address public health disparities, it is time we face this issue head on. We ask that local entities join the American Public Health Association by declaring racism a public health crisis. Similar measures have been accomplished in Columbus, Milwaukee and is now a stance taken by our neighboring county of San Bernardino as of June 9th, 2020. We believe this will send a clear and direct message to all public health officials and healthcare providers to strengthen collaboration and dialogue to improve health outcomes for the Black community as well as other racial and ethnic minorities.

As future physicians, we are invested in what medicine accomplishes and are committed to ensuring that its practice benefits all residents of this country equitably. We are on this career path to improve healthcare outcomes for our communities and it would be irresponsible for us to stand idly while Black residents continue to be targeted by systematic violence and health care

inequity. Our ultimate goal is to promote a safe and healthy environment for all residents, but for that to be accomplished, we must first declare racism a public health crisis.
