**BACKGROUND:**

**Summary**

The Department of Animal Services (DAS) proposes to accept the donation of one (1) 2017 Ford Transit Van from Best Friends Animal Society (BFAS) for use in the Coachella Valley. Once title is transferred to the County of Riverside, DAS will be responsible for the cost of maintenance and repair of the vehicle. The vehicle currently has approximately 59,061 miles. Once ownership is transferred, CVAC will utilize this van to conduct lifesaving work through various shelter programs. The Kelly Blue Book fair market value is \$17,051.

The van is identified as: 2017 Ford Transit T-150

**Impact on Residents and Businesses**

Accepting the donation of this vehicle will benefit Coachella Valley residents. The vehicle will be housed at the Coachella Valley Animal Campus and will enable staff to continue lifesaving work in the Coachella Valley.
