

# BACKGROUND: Summary

On December 4, 2018, Item 3.21, the Board of Supervisors (Board) approved in-principle and preliminary project budget in the amount of \$440,242, for the County Fire Station 34 Driveway and Fencing Project. The goal of the Project was to increase the security at the perimeter of the facility due to vandalism and break-ins. The scope of work included new concrete driveway into the facility off of Haddock Street, installation of motorized vehicular gates with entry and exit keypads, security fencing surrounding the entire property, and concrete work to accommodate the vehicular gate track.

On December 4, 2018, Item 3.12, the Board approved the construction contract for Job Order Contract (JOC) No. 010 between the County of Riverside (County) and Horizons. Pursuant to the contract, three job orders were issued in the cumulative amount of \$309,081 for the County Fire Station 34 Driveway and Fencing Project.

Horizons has completed the work satisfactorily, and the Project has been inspected and found to comply with the contract requirements. This Board action will release the undisputed contract retention funds in the amount of \$15,455 to Horizons, after the Notice of Completion has been recorded and the 35-day lien period has expired per contract terms and applicable law.

#### Impact on Residents and Businesses

The completion of the Project has provided the Fire Department enhanced security for staff and will reduce vandalism to the facility.
