**BACKGROUND:**

**Summary**

Riverside County Ordinance 695 established an on-going program to abate hazardous vegetation, while at the same time, protecting rare and sensitive plant and animal species and the environment. The purpose of the Hazard Reduction program is to reduce or eliminate fire hazards created by vegetative growth and the accumulation of combustible debris, which poses a danger to the health, safety and welfare of the residents in the vicinity of any real property, as well as irreparable harm to sensitive habitat and species. Fire Prevention Technicians annually inspect unimproved parcels within the unincorporated areas of the County of Riverside, as defined by Riverside County Ordinance 695.4.

Once all inspections are completed, an “Order to Abate” was sent to each owner of record. The order advised the parcel owner of their obligation to have the parcel in compliance within thirty days from the date of notice. Upon re-inspection, the Riverside County Hazard Reduction program turned over any parcel, found to be non-compliant, to the County Contractors for abatement. At the conclusion of the abatement, a bill was issued to the parcel owner of record. If not paid, then the County has the ability to recover abatement costs by assessing real property. This assessment incorporates the contractor's costs and the County administrative fee of \$254.

The properties that are subject to this assessment are attached as Attachment “A” to the resolution. The Board of Supervisors, in the meeting on June 30, 2020, gave approval to set a public hearing for the adoption of Resolution No. 2020-058, confirming special assessments for the cost of abating hazardous weeds. On July 1, 2020, notice of the August 4, 2020, hearing was mailed to each affected property owner. Upon the closing of this public hearing on August 4, 2020 the special assessments and liens are confirmed.

**CEQA**

As part of the amendment to Riverside County Ordinance No. 695 (Ordinance No. 695.4), an Environmental Assessment leading to a Mitigated Negative Declaration (State Clearinghouse No. 2009041105; EA/MND) was completed as required by the California

Environmental Quality Act (CEQA). The EA/MND was circulated for public review on April 22nd, 2009 to May 21st, 2009. The final EA/MND was approved as part of the adoption of the amended ordinance on June 16th, 2009. There were no legal challenges to the approved EA/MND. As part of the project description, the EA/MND included the changes to the ordinance, as well as a detailed discussion as to how the Hazardous Reduction Office conducts annual inspections, identifies hazardous vegetation and combustible material, and executes the Notice to Abate process. The description also includes detailed procedures as part of the compliance manual as to how to proceed in areas of biological sensitivity. This Form 11 is merely executing the County's compliance with the amended Riverside County Ordinance No. 695.4 as it relates to the cost and reimbursement of weed abatement.

**Impact on Residents and Businesses**

The Hazard Reduction program is designed to protect life, property and the environment. Voluntary compliance is the primary goal for the program. The owner of record, for each parcel, is provided the opportunity to abate the property prior to the County conducting the abatement. The owner also has an opportunity to reimburse the County the cost of abatement prior to the lien process being initiated. The adoption of Resolution No. 2020-058 in the public hearing on August 4, 2020 of the list of those parcels not in compliance and subject to the abatement fee is the final step required under the Health and Safety Code Section 14910 and County Ordinance 695.4 to establish assessments and liens on those parcels.

**Additional Fiscal Information**

The abatement charges for any work performed by the contractor and the County administrative fee will be included in the property owner's property tax statement as a special assessment. The Board of Supervisors approved the administrative fee of \$254 by Resolution No. 2011-080 with a public hearing on June 28, 2011. The current total parcels are 445 and the total amount to be assessed is \$199,198. The assessments will reimburse the department costs, which are funded by the General Fund.

11                  WHEREAS, Health & Safety Code Section 14875 et seq. provides for  
12                  the abatement and removal of hazardous weeds; and

13                  WHEREAS, Riverside County in Ordinance No. 695 has established a  
14                  methodology for the removal of hazardous weeds in various areas of the  
15                  unincorporated portions of western Riverside County; and

16                  WHEREAS, Ordinance No. 695 was amended and adopted on June 16<sup>th</sup>,  
17                  2009, after an evaluation of all potential physical environmental  
18                  impacts pursuant to the California Environmental Quality Act; and

19                  WHEREAS, the CEQA document (State Clearinghouse No. 2009041105)  
20                  was provided for public review from April 22, 2009 to May 21, 2009;  
21                  and

22                  WHEREAS, Resolution No. 2020-058 is only related to the actual  
23                  implementation of Ordinance No. 695, which was previously evaluated as  
24                  part of the overall project under CEQA (State Clearinghouse No.  
25                  2009041105); and

26                  WHEREAS, Section 6A of Ordinance No. 695 provides for the mailing  
27                  of individual notices to the owners of such parcels advising them of  
28                  their obligation to remove the weeds on such lands or be charged for  
29                  the costs of such removal when the work is done by the County or by a  
30                  contractor hired by the County; and

31                  WHEREAS, such property owners have had the opportunity to object  
32                  through filing a written request, within fifteen calendar days of the

1 postmark on the Notice to Abate, as stated in the appeals procedure  
2 established in Section 6C of Ordinance No. 695; and

3 WHEREAS, on those parcels, where the removal was not carried out  
4 by the owners, the County, acting through various contractors, has now  
5 carried out the removal work required; and

6 WHEREAS, the charges placed upon the parcels is the cost of  
7 removal where the work was not carried out by the owners and is not a  
8 charge based upon the value of the parcels; and

9 WHEREAS, pursuant to Section 6F of Ordinance No. 695 the Fire  
10 Department shall render to the Property Owner an invoice demanding  
11 payment within 15 days covering the costs of the work necessary for  
12 such abatement; and

13 WHEREAS, the billing for those parcels listed on the  
14 attached Exhibit "A" remain unpaid; now, therefore;

15 BE IT RESOLVED AND ORDERED by the Board of Supervisors of the  
16 County of Riverside, State of California, in regular session assembled  
17 on August 04, 2020, that the list of parcels and costs of abatement  
18 for removal of hazardous weeds for each parcel as shown on Exhibit "A"  
19 are hereby confirmed and that henceforth said costs shall constitute  
20 special assessments against the respective parcels of land and are  
21 liens on said lands in the amounts of the respective assessments.

22 BE IT FURTHER RESOLVED AND ORDERED that a copy of this Resolution  
23 shall be transmitted on August 12, 2020 to the Auditor-Controller of  
24 Riverside County who shall enter the amounts of the respective  
25 assessments against the respective parcels of land as they appear on  
26 the current assessment roll. Said assessments shall be collected at  
27 the same time in the same manner as ordinary municipal ad valorem  
28 taxes as provided by Section 6G of Ordinance No. 695.


