Bryan J. Baltierra, who tragically died at the age of 18, in an amphibious assault vehicle (AAV) training accident, on July 30, 2020.

Bryan was born September 18, 2001 to Carlos and Evelyn Baltierra. He was the only son of their four children Natalie, Emily and Sara. Bryan died on the anniversary of his Marine Corps enlistment, just before his first deployment overseas, scheduled in September.

As a young boy Bryan aspired to join the military. He made it a reality after graduating in June 2019, from Centennial High School in Corona, where he ran cross-country all four years. Bryan was just 17 years old when he entered the Marine Corps and turned 18 finishing boot camp, where he earned the eagle globe and anchor - the official emblem and insignia that he was a U.S. Marine.

Bryan loved the brotherhood of being a Marine. He also craved the intense training and exercises. Despite being at Camp Pendleton, he remained in close contact with his family. They had a group chat, text and Snapchat, where Bryan shared his Marine Corps adventures.

Bryan radiated positivity primarily through his engaging smile. He was well liked by everyone he met. There was always a lot of smiles and laughter with whomever he was with. Bryan enjoyed paintball and going to concerts. He loved eating at Panda Express and he listened to old school Rhythm and Blues music.



"Dick" Johnson, a long-time local Realtor, passed away peacefully at the age of 84, on Monday, June 1, 2020.

In 1954, a 19-year old farm boy from Clarkfield, Minnesota, enlisted in the United States Air Force. He wanted to escape farm life and bitter Minnesota winters. In the Spring of 1960, after spending a little over four years working and traveling in the U.S. and throughout Europe with the United States Air Force, Dick made a cross country vacation drive to visit his eldest brother in Riverside, California, and never left. He thought he had found paradise. He often commented that the most beautiful thing he had ever seen were snow-capped mountains in the distance, with palm trees blanketing the foreground. This was as close to the snow as he ever wanted to be again.

Dick was employed with Rohr Aircraft performing data processing, before becoming employed with the City of Riverside, where he worked for approximately 15 years as the Director of Data Processing. He resigned in March 1973, to pursue his real estate license. It did not take him long to realize that real estate was his true passion. He took great pleasure assisting his clients and being a trusted advocate for them, as well as being a resource to his fellow Realtors.

Dick was proud of being a Catholic convert. He loved God, his faith and his church. In 1997, he was instrumental in securing \$2.1 million in funding for St. Catherine's of Alexandria's capital campaign to fund improvements to the parish school, parish hall and ministry center. A mission he had little time for while managing a busy real estate career, however this was something he felt he was called to do. It was one of his proudest achievements. Dick also had a passion for anything tropical and especially Hawaii, he proudly sported Hawaiian shirts regardless of the occasion. He loved cruises to the islands, he also enjoyed bowling for numerous years with the Lads and Lassies Vegas League.

On motion of Supervisor Spiegel, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, August 4, 2020 be adjourned in memory of John Lewis, Civil Rights icon and longtime congressman, passed away July 17, 2020, after a battle with pancreatic cancer.

Every forward movement of the Civil War Era seems, in some way, to have had a connection to Mr. Lewis. He was one of the original 13 Freedom Riders who challenged segregated interstate travel. He helped found the student Nonviolent Coordinating Committee, which coordinated lunch-counter sit-ins.

Mr. Lewis is the last surviving speaker from the March on Washington, an event that he helped organize. He also led the Selma March for voting rights. He and others suffered physical violence during this protest in an infamous event now known as "Bloody Sunday" images from this protest spurred support for the Voting Rights Act. In 1986, Mr. Lewis was elected to congress, where he served until his death.

Mr. Lewis' memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will always be remembered as a leader of the Civil Rights movement and a true public servant. He will be greatly missed but never forgotten.


