- 3. Expand the local program support to include comprehensive wrap around services and the establishment of a financial assistance fund to support farm and food processing employees who have lost income due to COVID-19 illness or quarantine;

BACKGROUND:

On July 24, 2020, Governor Gavin Newsom announced the launch of the Housing for the Harvest program. The program is designed to provide temporary hotel housing options for essential farm and food processing employees who are either COVID-19 positive or exposed and who do not require hospitalization, to have safe and suitable places to isolate when they are unable to do so at home.

The COVID-19 pandemic has disproportionately affected rural communities and essential workers in the Eastern Coachella Valley. The farmworker communities of Thermal, Mecca and Oasis have the highest per-capita rates of infection and death in the County of Riverside. Thermal, Oasis and Mecca have had more than 1,200 cases, and this equates to roughly 10% of the overall population of these farmworker communities. In comparison roughly 2% of the entire County population has contracted COVID-19. The inability to socially distance, the inability to stop working and the inability to qualify for benefits due to their legal resident status continue to exacerbate the problem.

The County's farm worker community needs our help. We are recommending the County's Department of Housing, Homelessness Prevention and Workforce Solutions work with the State to secure Harvest program funding to provide aid relief for farmworkers who need to quarantine due to COVID-19. The Riverside County program will include: state funded hotel/motel rooms for isolation/quarantine, expanded housing options including the use of previously allocated state travel trailers; an experienced lead program coordinator (TODEC) to coordinate outreach, housing services, wellness checks, and ancillary supportive services; and the establishment of a financial assistance fund for impacted workers.

Dear Riverside County Board of Supervisors,

On behalf of the Latino Community Foundation, I write in support of providing temporary housing options for essential farm and food processing workers who have tested positive for COVID-19 or have been exposed and do not require hospitalization. Providing these workers with safe and suitable places to isolate when they are unable to do so at home is critical to helping reduce the spread of the virus in the county.

Today, Riverside County's coronavirus case count is at 49,482 cases, six times higher than it was in June. Farm and food processing employees continue to be at high risk for becoming infected. These frontline, essential workers labor long hours in close proximity to other workers, and often live in multifamily housing that facilitates the rapid spread of the virus. Many are also without a legal status, which means they were excluded from the federal relief offered to millions of families earlier this year.

This past March, LCF created the Love Not Fear Fund to support grassroots Latino-led organizations serving Latino and immigrant communities across California. TODEC Legal Center is one of the organizations in the region that we've supported through our philanthropic efforts. In addition to helping the organization maintain its regular services, these funds were used to provide community members with food assistance, immigration and legal services, and other COVID-19 critical resources across the county.

It is for these reasons that I respectfully ask the Riverside Board of Supervisors to work with TODEC Legal Center to create and implement a program that is able to provide farm and food processing workers with temporary housing options in the case they become infected or exposed to COVID-19 and do not require hospitalization.

LCF is the premier statewide foundation focused on unleashing the civic and economic power of Latinos in California. The foundation has the largest network of Latino philanthropists in the country and has invested \$10 million to build Latino civic and political power and leadership in the state.
