RECOMMENDED MOTION: That the Board of Supervisors:

With regard to the annexation of Street Lighting Zone 132 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated, conduct the public hearing and, after closing the public hearing, direct the Director of Transportation, or her designee, who the Board of Supervisors finds to be an impartial person as that term is used in Section 53753(e) of the Government Code, to tabulate all ballots received prior to the close of the public hearing. All ballots received prior to the close of the public hearing will be tabulated at 10:00 a.m. on Wednesday, August 26, 2020 in Conference Room C on the 8th Floor of the County Administrative Center, 4080 Lemon Street, Riverside, California. Staff is directed to cause the appropriate resolution, based on the election tabulation, to be prepared and returned to the Board of Supervisors for its consideration.




BACKGROUND:

Summary

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution No. 2020-126 adopted June 30, 2020, the Board of Supervisors gave notice of a public hearing for August 25, 2020, to receive testimony regarding the Annexation of Street Lighting Zone 132 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LMD No. 89-1-C). Annexation of Street Lighting Zone 132 will fund the maintenance and servicing of streetlights within public rights-of-way located north of Bedford Motor Way, south of Weirick Road, east of Retreat Parkway and west of Knabe Road in the El Cerrito area and includes one commercial parcel totalling 12.76 acres.

The annexation of territory to an existing assessment district formed under the Landscaping and Lighting Act is a change of organization that requires a public hearing as part of the annexation process. Str. & H. Code §§ 22605(a), 22607, 22588; Gov't. Code § 53753(d).

On July 1, 2020 a notice of the public hearing and information sheet, a mail-in ballot, an impartial analysis, and a copy of Resolution No. 2020-126 was mailed to all property owners within Street Lighting Zone 132, proposed for annexation to L&LMD No. 89-1-C. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2020-126 in an appropriate newspaper at least ten (10) days prior to the public hearing date and by posting a certified copy of Resolution No. 2020-126 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two (2) other public locations within the County.

Impact on Residents and Businesses

The new assessment is for the purpose of providing the maintenance and servicing of streetlights within public right-of-way.

Only the commercial property owners within the proposed boundaries of Street Lighting Zone 132, which are represented by Plot Plan No. 26097, as described in the attached Exhibit "A" (a two-page exhibit containing a description and diagram) are impacted by the cost of this

annexation. The property owners within the proposed boundaries of Street Lighting Zone 132 have petitioned the County of Riverside to annex their property to L&LMD No. 89-1-C and understand that this annexation will result in an assessment on their property to fund the maintenance and servicing of the aforementioned improvements (streetlights).

SUPPLEMENTAL:

Additional Fiscal Information

The proposed budget for fiscal year 2021-22 for Street Lighting Zone 132 is \$1,099.00. This will result in an assessment for fiscal year 2021-22 within Street Lighting Zone 132 of \$86.00 per acre. The annual assessment may be adjusted annually by the greater of 2% or the cumulative percentage increase in the Consumer Price Index for all Urban Consumers for electricity (CPI-U), if any, as it stands as of March of each year over the base index for March of 2021.

DESCRIPTION OF BOUNDARIES

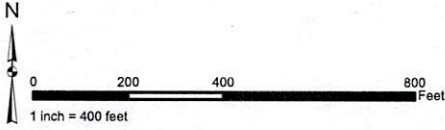

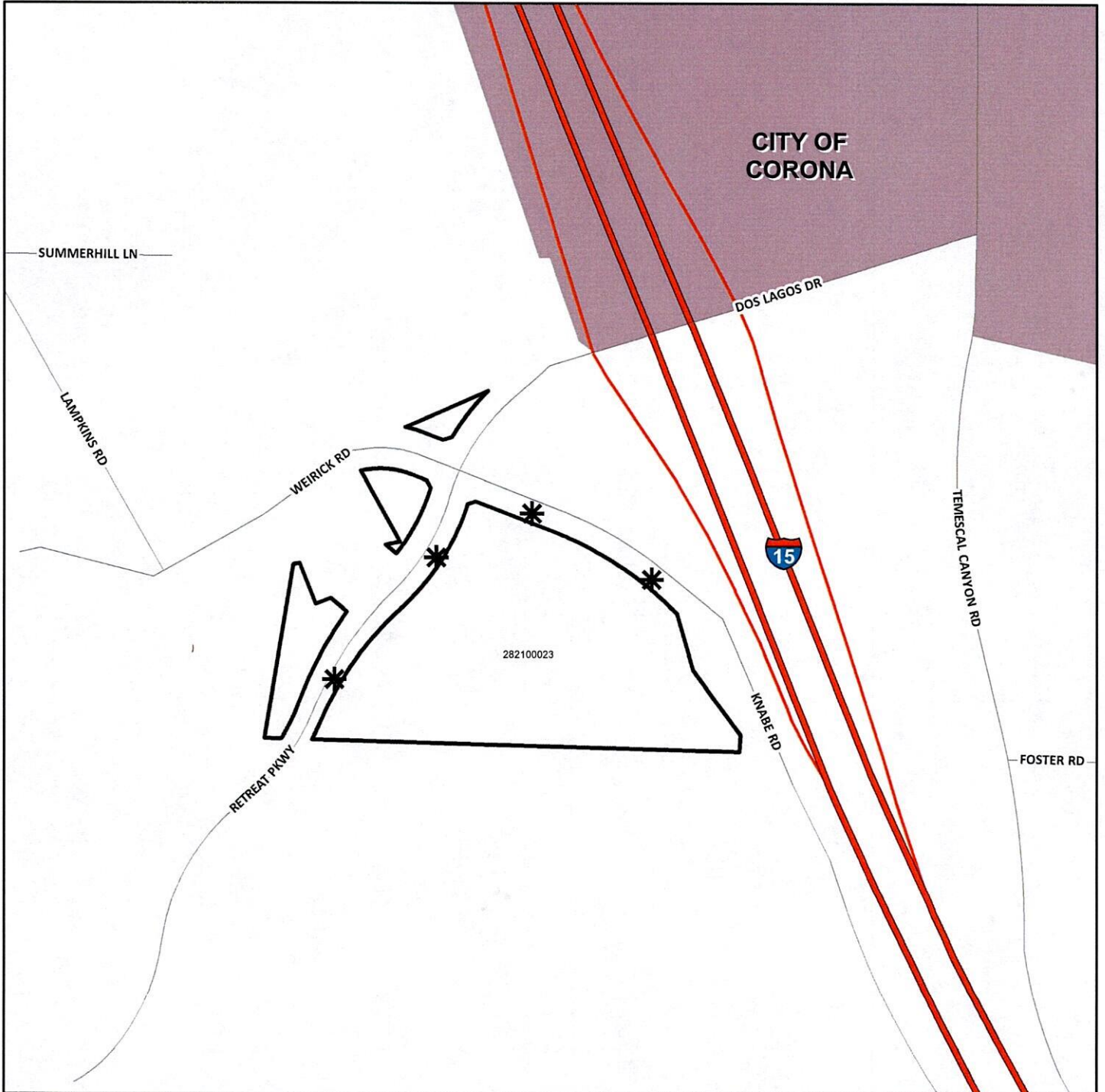
STREET LIGHT ZONE 132
