BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the May 01, 2018 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 26, 2018. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 18, 2018, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as various other research methods were used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received two claims for excess proceeds:

- Claim from County of Riverside Code Enforcement Department based on a Notice of Pendency of Administrative Proceedings recorded on December 04, 2012 as Instrument No. 2012-0586889.
- 2. Claim from Andy Teasley based on a Quit Claim Deed recorded on March 08, 2006 as Instrument No. 2006-0167236.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that County of Riverside Code Enforcement Department be awarded excess proceeds in the amount of \$6,385.80. Since the amount claimed from County of Riverside Code Enforcement Department exceeds the amount of excess proceeds available there are no funds available for consideration for the claim from Andy Teasley. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimant by certified mail.
