Joel was born October 15, 1940 in Huntington Park, California, and grew up in South Gate. He was the proud son of a Supervising rubber worker, at the B.F. Goodrich tire factory. His mother was a secretary who went to college in her 60's and later became a realtor.

Joel arrived at the recently opened University of California, Riverside, in 1958, and became editor of the school paper. In 1962, he married Carol Ryan. Joel joined the Press-Enterprise in 1965, and eventually joined the editorial team. In 1977 he cobbled together a Saturday page, providing kids with games, puzzles and trivia. Joel became chief editorial writer and was editor of the Editorial page in 1984.

After retiring in 2002, Joel embarked upon a one-word mission at Highgrove Elementary School; reading. Day after day, the kindergarteners read while Joel listened. He was their audience, their cheerleader, their champion. He was a volunteer known everywhere as Mr. B. He began ordering books and giving them away. After kids discussed what they had read with Mr. B, they would get another book. He was so giving, in an academic but loving way. When Highgrove could no longer afford to send the top readers to Disneyland, Mr. B helped pay over the years. Joel volunteered at Highgrove for almost 15 years, and was named the school district's volunteer of the year. Though he had cut back his hours, he was still at Highgrove when the pandemic hit. He hadn't ruled out going back.



When he returned to Riverside, his Ramona coach, Fran Bushman, got him a tryout with the California Angels and he played on the AAA team in Arizona.

Don was drafted and joined the U.S. Marine Corp. During his tour in Vietnam he was awarded the Bronze Star for Valor and a Purple Heart. After completing his tour in the service in 1968, he married his sweetheart Norette Goodgame. They were married for 52 years.

Don was an entrepreneur, starting numerous foodservice businesses in the Inland Empire, and owned the first food truck in the county in 1972. He also co-created the employment company Auto Careers.

Don was a man of many talents. He was an avid golfer, fisherman, and tennis player. He was self-taught on the piano, guitar and mandolin. Don wrote poetry and loved to write limericks for family and friends celebrations. Don's generosity was not kept just for family. One Christmas Eve he read of a local family not having gifts for their children, he and his family drove a car full of gifts to the house. This started a tradition of Christmas parties that provided gifts for local families and continues to this day.

Martin spent the majority of his career as a Commercial-Agri-business real estate appraiser. He served as a winery appraiser and consultant from 1987 until he passed. Martin was elected to Rancho California Water District's Board of Directors in 2015, serving as the board's Senior Vice President in 2019 and 2020. He was Chairman of the Engineering and Operations Committee and served on the Finance and Audit Committee. During his tenure, Martin helped create the CropSWAP Program which provides financial incentives to the District's agricultural customers for replacing high-water-use crops with lower-water-use varieties.

Martin was also a winegrower and one of the region's biggest champions, serving on the Temecula Valley Winegrowers Association's Board of Directors since 2014, and serving as the Board's president from 2017-2018. Martin was also at the helm during the Temecula Valley Southern California Wine Country 50th anniversary in 2018, and when the regions made the list of Top 10 Wine Getaways, by Wine Enthusiast magazine. Martin was an innovative and passionate advocate for his community.

James "Jim" Lamberton Mitchell was born June 5, 1936 in Chicago, Illinois. He earned his bachelor's degree in history from Stanford University. After Stanford, Jim received a commission in the U.S. Coast Guard. He was stationed in Panama as part of the U.S Small Craft Inspection and Training Team, which he later received a Legion of Merit Medal.

After his service in the U.S. Coast Guard, Jim worked as a radio announcer, a TV consumer reporter and news reporter, for ABC news. Jim and his wife Meryle, moved to Temecula in 2001, and became very active in the community. He successfully opposed the "UpZoning" of property immediately adjacent to the wine country.

Jim joined Save Our Southwest Hills and together with the Pechanga Band of Luiseño Indians and the City of Temecula won a hard fought, fight against a proposed quarry mine on Pu'eska Mountain. He also arranged local debates for candidates running for Temecula City Council and the Riverside County Board of Supervisors, and established the Santa Margarita Group of the Sierra Club.


