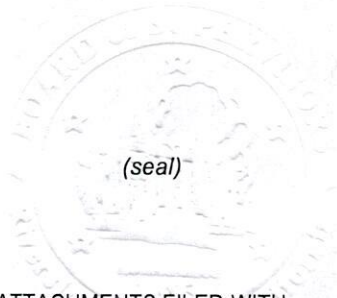

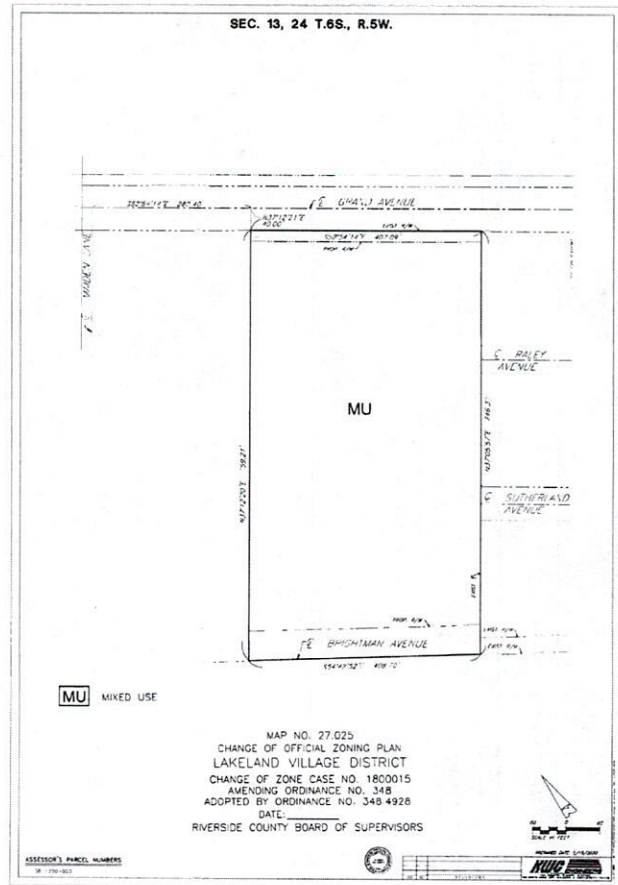

**ORDINANCE NO. 348.4928  
AN ORDINANCE OF THE COUNTY OF RIVERSIDE  
AMENDING ORDINANCE NO. 348 RELATING TO ZONING**

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 4.1 of Ordinance No. 348, and Lakeland Village District Zoning Plan Map No. 27, as amended, are further amended by placing in effect in the zone or zones as shown on the map entitled "Change of Official Zoning Plan, Lakeland Village District, Map No. 27.025 Change of Zone Case No. 1800015," which map is made a part of this ordinance.

Section 2. This ordinance shall take effect 30 days after its adoption.
