

BACKGROUND:

Summary

The Val Verde Unified School District notified the Riverside County Sheriff's Department on January 30, 2020 of their desire to terminate the Law Enforcement Services Agreement pursuant to Section 8 of the Agreement effective March 1, 2020. On June 25, 2019, the Board of Supervisors approved the Two Year Law Enforcement Services Agreement with the Val Verde Unified School District for the provision of two (2) Deputy Sheriff School Resource Officers.

The Department has included no cost estimate in its budget; therefore, no budget adjustment is necessary. County Counsel has reviewed the termination request and approved the Termination of the Agreement as to form.


