

Summary

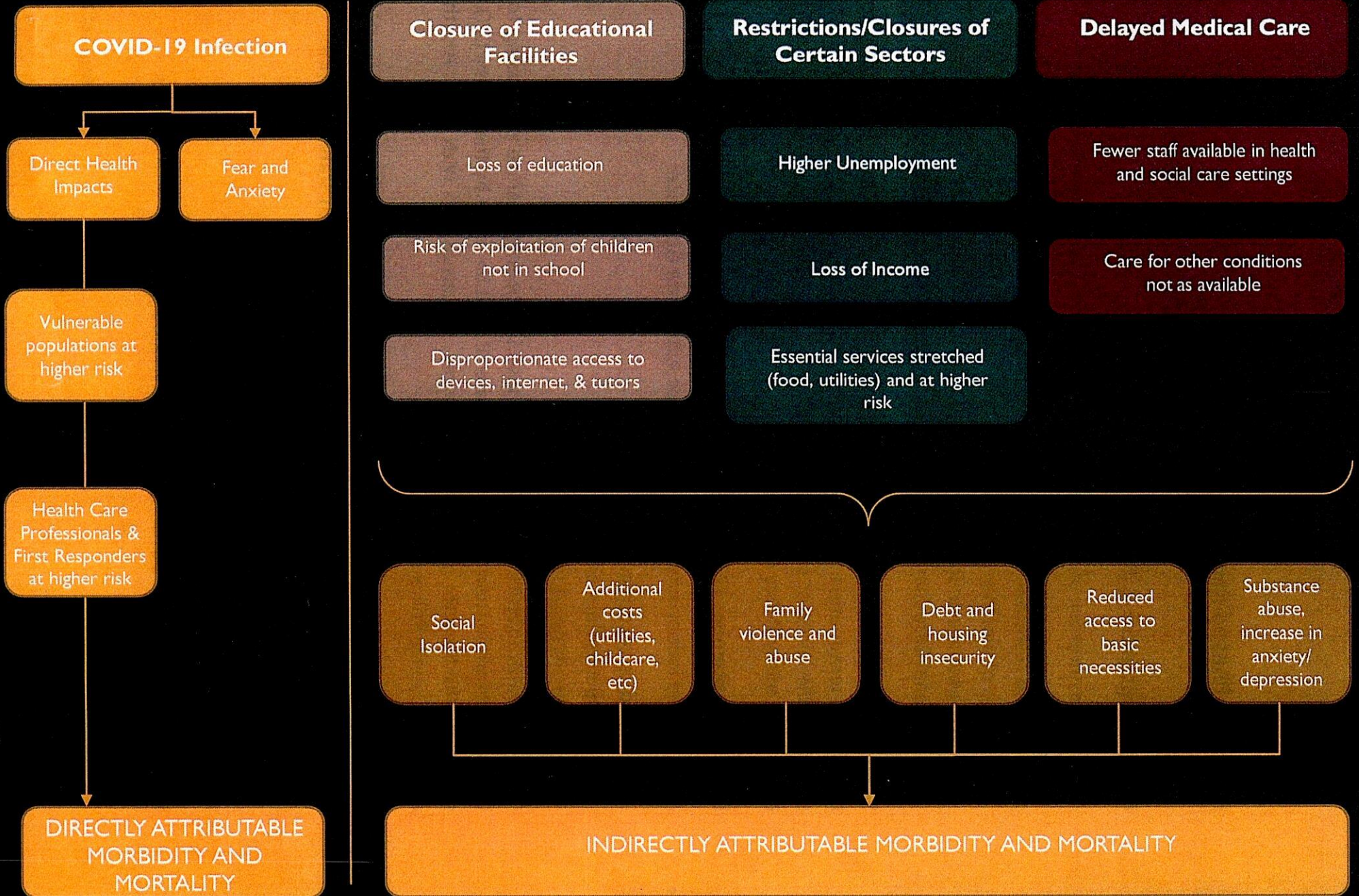
On January 29 we received a plane full of diplomats and their families from the Wuhan District of China. Riverside County stood ready to house and treat the very first plane of peoples escaping COVID-19. This would be one of many examples of our preparedness and resolve to fight for the health and wellbeing of our residents. The bold and swift actions of Public Health, EMD, RUHS and many others have made Riverside County not only a haven, but an example to other counties across the country on how to deal with COVID-19.

Six months after the first "15 day" shutdown, our economy is still not open. We have experienced a disturbing pattern of achieving California state requirements only to have the standards changed. Testing requirements, positivity rate, the number of hospital beds, and many other metrics have been adjusted; forcing our county to remain shut down. The state's lack of clear guidelines has left thousands of people uncertain about their abilities to pay bills and provide for their families.

Today the economic impacts are clear, thousands of businesses and hundreds of thousands of jobs have been lost due to the shutdown of our economy. We will feel the burden of these economic impacts for years to come. It is time for Riverside County to take responsibility for our own wellbeing. By following these guidelines for reopening our economy, we will be protecting the most vulnerable in our society from contracting this deadly virus.

The plan laid out below is phased in such a way that we can monitor the impacts of changes made; placing the health of our residents first. It is paramount that we continue to socially distance ourselves, wear face masks when in public spaces and protect the health and safety of the elderly and immunocompromised. We must also continue to test those who are sick, and those who show no symptoms, so we can monitor our progress.

For the first time in my sophomore child's school life, she was broken and in tears as she struggled in her 1st AP class late into the night. As I held her, I was infuriated.

This kid has been taught by amazing teachers the importance of collaboration with others as part of your growth socially and academically. She is one of the smartest human beings that I know and for the first time, she doubts herself.

When you are in tough classes, it's crucial to get to know the students in your class and begin conversations and develop relationships to help you grow in your thoughts and actions. Studying together and wrestling through thoughts and helping each other is absolutely part of that process. She was taught this in Skull Island (group collaboration emphasis) last year and has excelled.

Now, these kids are on an island. In a bubble. It's expected that they will have classes where they may not know their classmates. But how in the world can they get to know anyone now?!?! They have lost a key part of being able to talk before, during and after school with each other about homework. There is no "study hall" to get help from each other.

Teachers are only 1 part of their education. Interaction is a huge part! Does our governing system in this state not understand that they are clearly failing our kids?!?! Even if they go back into a class, social distancing is still a bubble!!!

I can't help her and I, too am broken and infuriated. I cannot replace what her peers should be doing.

So many of us are fighting for our kids, but no one seems to be listening.

There is absolutely no data that justifies what has been done to all of our students. We are exposed to death every single moment of our lives by multiple viruses, diseases and countless other things. We have been spreading germs as humans for thousands of years! Because of herd immunity, the human race has continued and has not died off! Look around, for goodness sakes, most of us have survived so much worse!

Fear is a monster that has caused more destruction than all of these combined.

I am so angry and disappointed in what many people have chosen to become and control in this state that i am raising my kids in. I am disappointed in many educators that have chosen the route of fear. The teachers that desperately want to be back with their students: I cannot thank you enough for trying to teach in such a unique setting that limits the use of your complete talents. Just remember, they are missing a huge chunk that is provided by being with other students.

She missed her limited soccer practice, her main outlet (also affected by political control) last night, due to this. However, I realized that had she been at school, she would have been able to establish relationships with students in class and been part of a study group that could have prevented her break down and probably not missed her practice. Last year she had a tough schedule as a freshman and these groups helped her manage all her activities and stay at the top of her class. These types of groups and study halls do not exist with today's limitations. It's missing as is absolutely necessary.

They need grace. They need school.

We have successfully done what was asked in order to 'flatten the curve' and 'slow the spread'. It's time to resume living. In the past month we have seen 2 local teens lose their lives to substance over-dose. My own kids are suffering from depression and anxiety. One has begun seeing a therapist, and I believe the other two will do the same shortly. They make statements such as "There's nothing to look forward to", "It's a never-ending loop of zoom calls and screen time without any real talking", and "Why bother with school if we can't even go back?" They see their friends in other states going to football games and homecoming dances and feel even worse about their situation and even more hopeless. They see neighboring friends in other counties resuming their sports and activities as well as their in person learning with hybrid schools and they ask if we can move. This **MUST** end. This is **NOT** sustainable.

Read THIS!

I am no longer willing to allow my kids to be the pawns in some governmental game. I demand that my elected officials and county representatives stand up for us. We can **NOT** be afraid of potential effects of a virus we **might** catch. We **MUST** be afraid of the damage (long-term as well) that we are inflicting on this generation of teens and children by forcing them to hide behind a screen and putting them at risk for trafficking, pedophiles, mental health issues, and substance abuse.

I have 2 high school students - both student athletes. In March when school closed and sports were stopped we held tight to the idea that this was only temporary and we could take this time to focus on other important things before getting back to our busy school and sports schedule.

Now, in the middle of month 7, we no longer spend our time on hope as it is clear the state of California and Stanislaus County are not interested in what is best for our kids.

They spend their days staring at a screen full of other students who sit at home and a teacher barely hanging in there. They have closed our basketball courts and stopped all conditioning for sports. One person under 18 has died in the state of California. That child also had underlying conditions.

My children started therapy this week. My son has spent the last 2 weeks in his bed, not changing his clothes and telling me there was no reason to get up and keep doing all of this if he wasn't going to be able to get into college or continue playing soccer. He has played since he was 4 years old. He plays at the very top level of competitive soccer in the state. He was being recruited by 5 colleges before covid19. Now we have no idea if he will ever get a chance to play. I can't offer him any advice because I don't know either. He is depressed and sad and as a mother I am desperate to help him.

These restrictions on even outdoor sports are destroying the mental well being of our children. We need to allow them back to the fields, and pools and with other athletes and their coaches. Parents should have the right to make our own health and safety choices for our children and our families. Please help us get the message out that our kids need to play!
