BACKGROUND: Summary

The Advisory Committee for County Service Area 36 Idyllwild was established on June 14, 1977, by Resolution 77-189, for the purpose of advising the Board of Supervisors on policy matters relating to the general development of the facilities, programs and services of County Service Area 36 as authorized under Government Code Section 25212.4.

Board of Supervisors Policy No.A-21 provides that the Board of Supervisors may, in its sole discretion, dissolve an advisory committee if the Board determines that the advisory committee is no longer functioning consistent with Government Code section 25212.4 and Board of Supervisor Policy Nos. A-21 and A-48.

Since the Idyllwild Advisory Committee was established in 1977, there have been significant changes in the delivery of services within County Service Area No.36, most notably the inclusion of public meetings hosted by the recreational provider under contract with the County of Riverside. It is now desired by the Third Supervisorial District to dissolve the Advisory committee for County Service Area 36 Idyllwild.

A RESOLUTION OF THE BOARD OF SUPERVISORS

OF THE COUNTY OF RIVERSIDE

DISSOLVING THE ADVISORY COMMITTEE FOR COUNTY SERVICE AREA NO. 36 (IDYLLWILD)

WHEREAS, the Advisory Committee for County Service Area No. 36 (hereinafter referred to as "Idyllwild Advisory Committee") was established on June 14, 1977, by Resolution No. 77-189, for the purpose of advising the Board of Supervisors on policy matters relating to the general development of the facilities, recreation programs and services of County Service Area 36; and

WHEREAS, the formation of an advisory committee to give the Board of Supervisors advice regarding a County Service Area's services and facilities is discretionary under Government Code section 25212.4; and

WHEREAS, while the County currently has 59 County Service Areas, only 7 have advisory committees; and

WHEREAS, the Board of Supervisors has previously changed the structure of the Idyllwild Advisory Committee under Resolution Nos. 2000-312 in an effort to better suit the needs of the County Service Area No. 36; and

WHEREAS, Board of Supervisors Policy No. A-21 provides that the Board of Supervisors may, in its sole discretion, dissolve an advisory committee if the Board determines that the advisory committee is no longer functioning consistent with Government Code section 25212.4 and Board of Supervisors Policy Nos. A-21 and A-48; and

WHEREAS, since the Idyllwild Advisory Committee was established in 1977, the County has contracted with non-profit recreation providers for recreational programming and operations; and

WHEREAS, the recreational provider is contractually obligated to host public meetings to discuss budget, operations, and recreational programming; and

WHEREAS, the needs that existed when the Idyllwild Advisory Committee was established have since become the responsibility of the recreation provider; and WHEREAS, By Resolution 2020-207, superseding Resolutions 77-189 and 2000-312, it is now desired by the Third Supervisorial District to dissolve the Idyllwild Advisory Committee; NOW, THEREFORE BE IT RESOLVED, by the Board of Supervisors of the County of Riverside, assembled in regular session on Tuesday, September 29, 2020 that the Idyllwild Advisory Committee is dissolved, effective this date.
