Bill found joy serving in many capacities at Church on the Hill where the family attended for over 40 years. He served on the church council, and he was a member of the choir. Bill was often the narrator for the church cantatas. He recently volunteered with Operation Christmas Child, an organization which sends shoe boxes filled with gifts to kids around the world. Erika was born on December 30, 1923 in Vienna, Austria. A refugee from Nazi occupation of Vienna, she lived in New York City prior to marrying her husband of over sixty years, Nicholas Schwartz. They relocated to Indio, California in 1948 and moved to Corona, California in 1954. They established their retail business Schwartz Furniture and Appliances in Corona, and successfully owned and operated it for over 50 years.

Erika and Nicholas participated in numerous community and civic activities and were one of four founding families of Corona's only Jewish Synagogue. She received citations from the Governor of California and a member of Congress for her work organizing and speaking at events involving thousands of local high school students to educate them on the Holocaust.
