

### **BACKGROUND:**

#### Summary

Tract Map No. 36826 was originally approved at Planning Commission on August 2, 2017. It proceeded to the Board of Supervisors as a receive and file item on September 28, 2017.

The First Extension of Time was received June 23, 2020, ahead of the expiration date of September 28, 2020. The applicant and the County discussed conditions of approval and reached consensus on July 16, 2020.

The County Planning Department, as part of the review of this Extension of Time request, recommends the addition of seven (7) new conditions of approval, in order to be able to make a determination that the project does not adversely affect the general health, safety, and welfare of the public. The applicant was informed of these recommended conditions and has agreed to accept them. Included in this staff report package are the recommended conditions of approval, and the correspondence from the Extension of Time applicant July 16, 2020 indicating the acceptance of the seven (7) recommended conditions.

The Planning Commission heard the First Extension of Time for Tentative Tract Map No. 36826 on August 19, 2020. The Planning Commission approved the project by a vote of 5-0.

#### **Board Action**

The Planning Commission's decision is final and no action by the Board of Supervisors is required unless the applicant or an interested person files a complete appeal application within 10 days of this notice appearing on the Board's agenda.

#### Impact on Citizens and Businesses

The impacts of this project have been evaluated through the environmental review and public hearing process by the Planning Department and the Planning Commission.
