



BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from Universities or community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the

Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two-year terms.

Dr. I. Angelov Farooq, is the owner of AVM Innovation Consulting, LLC. He was elected on the Board of Education for Riverside Unified School District (RUSD). In Addition, he also serves as the Director of Economic Development and Innovation for UC Riverside. Dr. Farooq earned his bachelor's degree from UC Berkeley, an Executive Master and a Doctorate of Policy, Planning and Development degrees from the University of Southern California. Dr. Farooq has served on the WDB for several terms and was also appointed as the Chairman of the California Workforce Development Board (CWDB) under the Governor Gavin Newsom administration. In 2019, Dr. Farooq was appointed to co-chair California Treasurer Fiona Ma's Housing, Economic Development, Job Creation & Opportunity Zone advisory Committee. He is an appointee of California Controller Betty Yee, on her Council of Economic Advisors. Dr. Farooq's knowledge and experience in economic and workforce development, is a great asset to the WDB.

Dr. I. Angelov Farooq has expressed interest in continuing to serve on the WDB as the Private sector representative for District 2. If reappointed he will serve a two-year term commencing October 12, 2020 and expiring October 12, 2022.
