BACKGROUND:

Summary

Pursuant to current law, the State Controller is required to allocate funds to each County that established an Enhancing Law Enforcement Service Activities Subaccount (ELEAS) in accordance with the proportionate share of the State's total population that resides in the cities within the County and the unincorporated area of the County.

Government Code 30061 requires the County Auditor-Controller to allocate the moneys in the County's ELEAS within 30 days of the deposit of those moneys into the fund.

Fiscal Year 20/21 Allocation ELEAS for COPS and JJCPA allocation is \$12,431,911 and will be received in monthly installment payments. The data on Attachment A represents the distribution for the COPS Program and the JJCPA. The Cities share of the total ELEAS allocation is \$3,917,076 and the County's share is \$8,514,835. The County's share will be distributed as follows: \$1,939,876 to the COPS Program and \$6,574,959 to JJCPA.

Impact on Residents and Businesses

Fiscal Year 20/21 ELEAS allocation is used to fund jail operations, criminal prosecution, front-line law enforcement, and a comprehensive multi-agency juvenile justice program.

SUPPLEMENTAL:

Additional Fiscal Information

Fiscal Year 20/21 ELEAS payments are received from the State between the months of September 2020 and August 2021, therefore payments to the Cities and the County will be allocated between FY21 and FY22. During FY21 total estimated amount to be allocated is \$9,024,500 and \$3,407,411 in FY22.

I am formally submitting both of my written comments for the record as I was not permitted to speak on item 3.4.

Opposition to 3.4:

Good morning Supervisors, my name is Avalon Edwards and I'm a policy fellow with Starting Over Inc. This past Saturday, Riverside residents took hours out of their days to share their county budget priorities to you. One of the most dominant themes in all three listening sessions was the call to reduce county funding to the Sheriff's Department and DA's Office in order to refund community services and programs. Today, the county is receiving \$8.5 million dollars of state funding to "fund jail operations, criminal prosecution, front-line law enforcement, and a comprehensive multi-agency juvenile justice program." These are programs and services currently being funded by both the state and county. With the understanding that the county will continue to receive significant funding from the ELEAS account for the foreseeable future, we ask that ELEAS and other state funding be taken into consideration when configuring the county's annual budget for law enforcement. If the county were to reallocate \$8.5 million dollars of county funding from law enforcement programs otherwise supported by state funding, we could meaningfully invest in housing security and re-entry programs for the most vulnerable in our community. With \$8.5 million dollars, we could build 50 housing units for single-parent families. Or we could build a vocational center to provide re-entry support to our community members leaving prisons and jails. With \$8.5 million dollars, we could fund the construction and maintenance of several youth centers, to provide safe opportunities for youth development instead of funneling our children into the prison system. An additional 8.5 million dollars sounds like pennies to be added to the pre-existing 350 million dollar county budget for the sheriff's department. But that funding is significant, and we ask that the county look at the real options available for us to reinvest in our youth and community wellbeing. Thank you.

Opposition to 3.13:

Good morning, this is Avalon Edwards with Starting Over Inc. This contract includes accountability loopholes, costly raises for probation officers, and unnecessary overtime pay for officers to literally sit at home in a time of profound economic struggle for the county and its residents. Officers are deemed unfit for duty when their supervisors perceive them to be a risk to themselves or the public that they serve. This contract will obligate the county to pay for potentially dangerous officers to refute claims of being unfit for duty. Taxpayer dollars will be spent to keep identified harmful officers working in our communities.

According to Glassdoor, the average annual salary of a Probation officer in Riverside county is \$48,130. If this contract is signed, those probation officers will be earning \$59,127 in 2025. That's 128% of what that officers are earning currently. I would like to remind the board that the average income of a Riverside County resident is \$23,660 a year. These residents have suffered tremendously during the spread of COVID-19, struggling with medical expenses, keeping up with rent, and putting food on the table with reduced hours and jobs lost. The pandemic has caused an urgent need for direct economic support to our struggling community members. This contract plans to siphon millions of dollars of county funding over the next 5 years into guaranteed salary increases and payment cushions for law enforcement officers. Instead, that funding can and should be used for direct aid programs like rental and food assistance for Riverside residents.

Additionally, this contact ensures wages for hours of "standby duty" which requires designated officers to stay home and sober during their standby hours. The residents of Riverside County will literally be paying Probation Officers to sit at home and stay sober. Officers asked to work from home outside of their regular hours will be paid 150% of their regular wage. If the county has the funds to give constant raises to law enforcement officers, then it should have enough money to provide the lifesaving direct aid that is needed by its residents in this economic and public health crisis.
