Adopt Resolution No. 2020-218 ordering the Annexation of Street Lighting Zone 134 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated, Winchester, District 3. [\$4,113 Ongoing - L&LMD No. 89-1-C 100%]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Adopt Resolution No. 2020-218, Resolution of the Board of Supervisors of the County of Riverside ordering the annexation of Street Lighting Zone 134 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated of the County of Riverside and confirming the diagram and assessment for Street Lighting Zone 134 of Landscaping and Lighting Maintenance District No. 89-1-Consolidated and levying assessments on all assessable lots and parcels of land therein within the boundaries of said zone for the fiscal year 2021-22;
2. Direct the Clerk of the Board to immediately file the diagram and assessment, or a certified copy thereof, with the County Auditor-Controller in accordance with Section 22641 of the Streets and Highways Code; and
3. Direct the County Auditor-Controller to establish an interest-bearing sub-fund 20300 to receive deposits and interest thereon from Street Lighting Zone 134 of Landscaping and Lighting Maintenance District No. 89-1-Consolidated; in accordance with Sections 22655 and 22656 of the Streets and Highways Code.

BACKGROUND:

Summary

Landscaping and Lighting Maintenance Districts (L&LMD's) are formed for the purpose of creating a funding mechanism to pay for the installation and maintenance of landscaping, streetlights, traffic signals, drainage inlet water quality filters, decorative fencing, and other roadside features within the road right of way. Within an established L&LMD, zones are created for specific developments, a fee structure is developed specific to the features within that zone, and the zone is then assessed through a tax levy on annual basis for the installation and maintenance of the features within that particular zone.

L&LMD No. 89-1-Consolidated ("L&LMD No. 89-1-C") was formed in 1994, Resolution No. 94-389, and currently consists of 146 individual zones with different fee structures spread throughout Riverside County. The commercial property owner of Tract Map No. 34677, as described in the attached Exhibit "A", has petitioned the County to annex their property into L&LMD No.89-1-C, creating Street Lighting Zone 134. The boundaries of Street Lighting Zone 134 will encompass the entire Tract Map No. 34677 and will include the maintenance and servicing of streetlights.

On August 25, 2020, a public hearing was held to receive all testimony regarding the annexation of Street Lighting Zone 134 to L&LMD No. 89-1-C. After closing the public hearing, the Board of Supervisors directed the Director of Transportation, or her designee, to tabulate the assessment ballots that had been received prior to the close of the hearing. The assessment ballots were to be tabulated on August 26, 2020 at 10:00 a.m. in Conference Room C on the 8th Floor of the County Administrative Center. The tabulation shows that votes representing 420 parcels out of a possible 420 were cast, and that 420 votes (or 100%) were cast in favor of the annexation of Street Lighting Zone 134 to L&LMD No. 89-1-C and the levy and enrollment of the special assessment.

Adoption of Resolution No. 2020-218 confirms the assessment levy as indicated in the Engineer's Report for fiscal year 2021-22 for Street Lighting Zone 134 of L&LMD No. 89-1-C and orders the placement of the annual assessment on the County's Assessment Roll for fiscal year 2021-22.

Impact on Residents and Businesses

The new assessment is for the purpose of providing the maintenance and servicing of streetlights within public right-of-way.

Only the residential property owners within the proposed boundaries of Street Lighting Zone 134, which are represented by Tract Map No. 34677, as described in the attached Exhibit "A" (a two-page exhibit containing a description and diagram) are impacted by the cost of this annexation. By setting up an assessment for the maintenance of certain infrastructure required by the development, the County requires that the development pay for its maintenance impact, rather than the obligation falling upon public funding sources.

Additional Fiscal Information

The proposed budget for fiscal year 2021-22 for Street Lighting Zone 134 is \$4,113.00. This will result in an assessment for fiscal year 2021-22 within Street Lighting Zone 134 of \$10.00 per parcel. Street Lighting Zone 134 includes 420 single family residences. The annual assessment may be adjusted annually by the greater of 2% or the cumulative percentage increase in the Consumer Price Index for all Urban Customers for electricity (CPI-U), if any, as it stands as of March of each year over the base index for March of 2021.

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE ORDERING THE ANNEXATION OF STREET LIGHTING ZONE 134 TO LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 89-1-CONSOLIDATED OF THE COUNTY OF RIVERSIDE AND CONFIRMING THE DIAGRAM AND ASSESSMENT FOR STREET LIGHTING ZONE 134 OF LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 89-1-CONSOLIDATED AND LEVYING ASSESSMENTS ON ALL ASSESSABLE LOTS AND PARCELS OF LAND THEREIN WITHIN THE BOUNDARIES OF SAID ZONE FOR THE FISCAL YEAR 2021-22

WHEREAS, on June 30, 2020 the Board of Supervisors (hereinafter the "Board of Supervisors") of the County of Riverside (hereinafter the "County") adopted Resolution No. 2020-090, pursuant to Section 22608 and Section 22585 et seq. of the Streets and Highways Code, declaring the intention of the Board of Supervisors to order the annexation of Street Lighting Zone 134 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (hereinafter "L&LMD No. 89-1-C") of the County pursuant to the Landscaping and Lighting Act of 1972, being Part 2 (commencing with Section 22500) of Division 15 of the Streets and Highways Code, and giving notice of and setting a public hearing for 9:30 a.m. on August 25, 2020 at the meeting room of the Board of Supervisors and requiring that the notice of the public hearing and assessment ballots be mailed to all owners of property within Street Lighting Zone 134 as shown on the equalized tax roll; and

WHEREAS, notice of said public hearing was duly published and mailed as required by Resolution No. 2020-090, Section 22588 of the Streets and Highways Code and Sections 53753 and 54954.6 of the Government Code and the assessment ballots were timely mailed to all owners of property within said Street Lighting Zone 134 as shown on the equalized tax roll; and

1 **WHEREAS**, at 9:30 a.m. on August 25, 2020, as set forth in Resolution No. 2020-090, the Board
2 of Supervisors held a public hearing and afforded all interested persons an opportunity to be heard, and
3 considered all oral statements and all written protest or communications made or filed by any interested
4 persons, closed the public hearing and directed the Director of Transportation, or her designee, as an
5 impartial person having no vested interest in the annexation of Street Lighting Zone 134 to L&LMD No.
6 89-1-C as required by Section 53753(e) of the Government Code to tabulate the assessment ballots
7 that had been received prior to the close of the public hearing; and

8 **WHEREAS**, the tabulation of the assessment ballots show that assessment ballots were timely
9 received from the owner of 420 parcels out of a possible 420 parcels and that 420 parcels (100 percent
10 of the assessment ballots received) voted in favor of annexation of Street Lighting Zone 134 to L&LMD
11 No. 89-1-C and the levy of an annual assessment in said Street Lighting Zone 134 beginning fiscal year
12 2021-22; and

13 **WHEREAS**, the Board of Supervisors may proceed, pursuant to Section 22594 of the Streets
14 and Highways Code, to adopt a resolution ordering the improvements and the annexation of Street
15 Lighting Zone 134 and confirming the diagram and assessment, either as originally proposed, or as
16 changed by the Board of Supervisors, and the adoption of such a resolution shall constitute the levy of
17 an assessment on all assessable lots and parcels of land within Street Lighting Zone 134 of L&LMD No.
18 89-1-C for fiscal year 2021-22.

19 **NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED** by the
20 Board of Supervisors of the County in regular session on November 17, 2020 as follows:

21 **Section 1. Findings.** The Board of Supervisors finds:

- 22 (a) the preceding recitals are correct;
- 23 (b) compliance has been had with all the requirements of the Landscaping and
24 Lighting Act of 1972, being Part 2 (commencing with Section 22500) of Division
25 15 of the Streets and Highways Code, and Sections 53753 and 54954.6 of the
26 Government Code;

- 1 (c) a majority protest to the annexation of, and annual assessment of, Street Lighting
2 Zone 134 of L&LMD No. 89-1-C has not been filed;
- 3 (d) the tabulation of the assessment ballots timely received was 100 percent voted in
4 favor of annexation of Street Lighting Zone 134 to L&LMD No. 89-1-C and the
5 levy of an annual assessment beginning fiscal year 2021-22, and 0 percent voted
6 no;
- 7 (e) the Board of Supervisors may proceed to adopt a resolution ordering the
8 annexation of Street Lighting Zone 134 to L&LMD No. 89-1-C;
- 9 (f) the Board of Supervisors may proceed to adopt a resolution confirming the
10 diagram and assessment for Street Lighting Zone 134 of L&LMD No. 89-1-C
11 either as originally proposed or as changed by it; and
- 12 (g) the assessments to be levied on the assessable lots and parcels of land within
13 Street Lighting Zone 134 of L&LMD No. 89-1-C for the maintenance and servicing
14 of streetlights in said Street Lighting Zone 134 during the fiscal year 2021-22 as
15 contained in the report of the Director of Transportation which is on file with the
16 Clerk of the Board of Supervisors (hereinafter the "Report") are based on benefits
17 derived by such lots and parcels from the availability of such streetlights
18 improvements, and are not based upon the ownership of such lots and parcels.

19 **Section 2. Annexation.** Street Lighting Zone 134, as proposed to be annexed to
20 L&LMD No. 89-1-C, which includes all the property subject to Tract Map No. 34677 in the County of
21 Riverside, State of California as described in Exhibit "A" attached hereto, shall be and is annexed into
22 L&LMD No. 89-1-C.

23 **Section 3. Improvements.** The improvements authorized for Street Lighting
24 Zone 134 of L&LMD No. 89-1-C are:

- 25 (a) Providing electricity to and the maintenance and servicing of streetlights within
26 the public right-of-way including incidental costs and expenses.

Section 4. Confirmation of Report. The Report and the assessment diagram and the assessment of estimated costs for the maintenance and servicing of streetlights in Street Lighting Zone 134 of L&LMD No. 89-1-C for fiscal year 2021-22 as contained in the Report are confirmed.

Section 5. Levy of Assessment. Pursuant to Section 22594 of the Streets and Highways Code the adoption of this resolution constitutes the levy of the assessment for the maintenance and servicing of streetlights in Street Lighting Zone 134 of L&LMD No. 89-1-C during fiscal year 2021-22, as contained in the Report, and such assessment is levied. The Clerk of the Board of Supervisors is directed to file a certified copy of this resolution, together with the diagram and assessment contained in the Report with the County Auditor-Controller of the County of Riverside, who, pursuant to Section 22645 of the Streets and Highways Code, shall enter on the County assessment roll opposite each lot or parcel of land the amount assessed thereupon, as shown in said assessment.

Section 6. Effective Date. This Resolution shall take effect from and after its date of adoption.

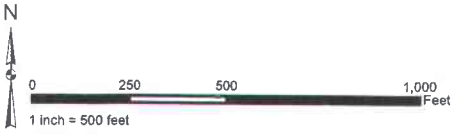
DESCRIPTION OF BOUNDARIES

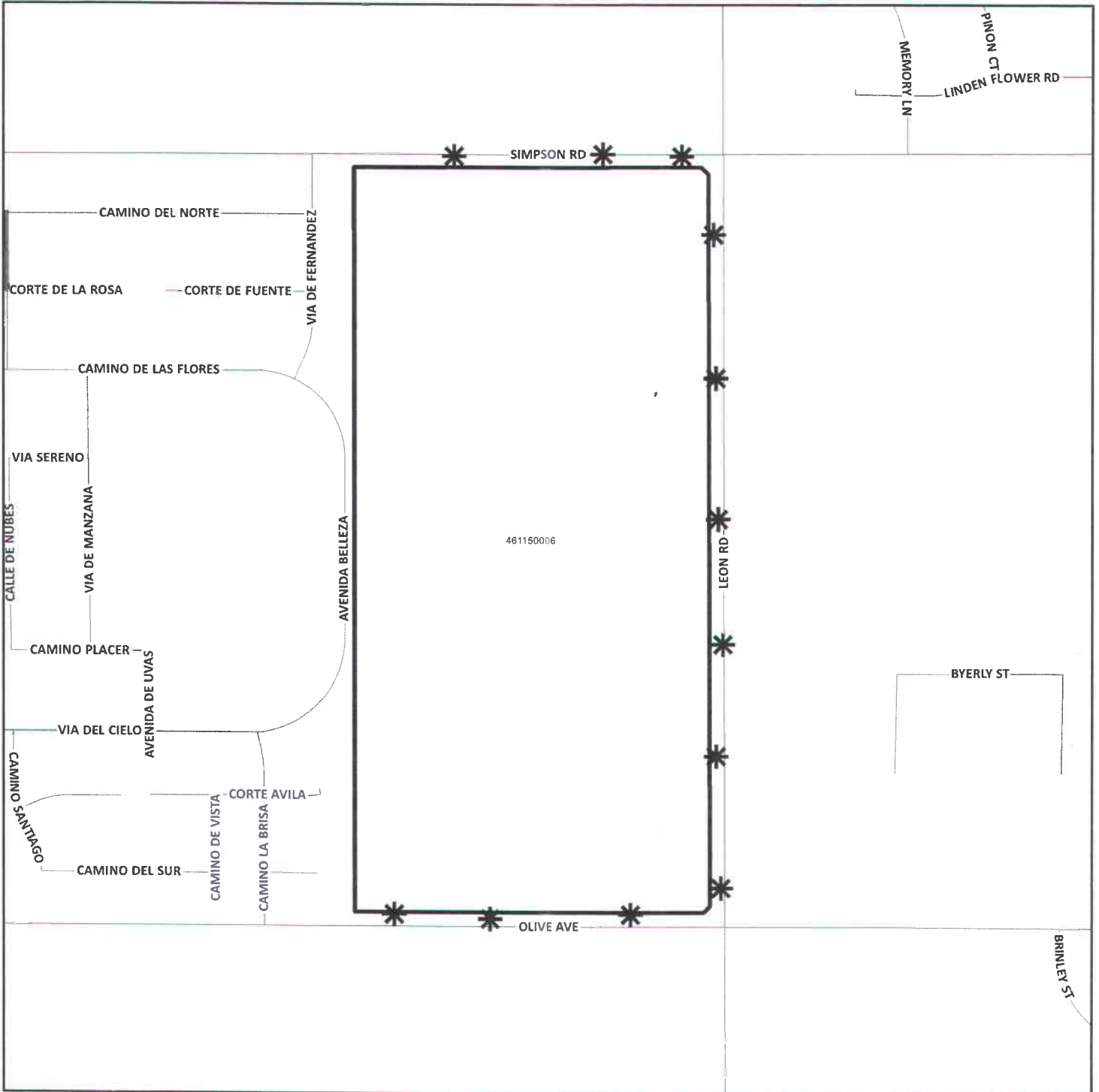
STREET LIGHT ZONE 134

420 PARCELS

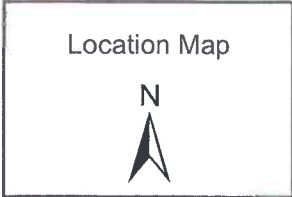
